I am so honored to serve the Fourth Council District, the community I was born and raised in and continue to call home. I was sworn into office this past April 8th, and since then I have been working hard to continue bringing the voices of our community to the forefront at city

First, we tackled the Fiscal Year 2025 Budget. As promised, I fought and restored core services and initiatives that directly impact families in the district. We successfully restored the Community Equity Fund, which will provide funding to flood impacted families for housing. I ask that you keep our impacted families in your prayers as we continue to work through recovery efforts. In June, the mayor signed a budget unanimously approved by the city council. The equity budget wins reflect my commitment to providing a more just allocation of funds, ensuring that we address the pressing needs of our neighborhoods.

In addition, we are diligently continuing our revitalization efforts of the San Diego Black Arts + Culture District. Thank you to Congressman Juan Vargas for his help in securing \$850K for the Marie Widman Memórial Park Improvements and \$850K for a historically disadvantaged small business revitalization program. In addition, I would like to thank Supervisor Monica Montgomery Steppe for awarding \$130K in discretionary funds for a mural and decorative crosswalks in the San Diego Black Arts + Culture District.

I am humbled for the opportunity to serve and thank you for your continued support. I look forward to working with you to strengthen our neighborhoods.

### **Appointment of New Fire-Rescue Department Chief**



On June 12, District Four's very own Deputy Fire Chief Robert Logan was appointed as the City of San Diego's
Fire-Rescue Department's new Chief. Deputy Fire Chief Logan began his career in 2000 and since then held
several positions culminating in 24 years of service. Congratulations Deputy Chief Logan on your new
appointment and dedication to keeping our communities safe.

### **Shot Spotters Are Coming Down in D4**



The City of San Diego entered into a contract for ShotSpotters, electronic devices that monitor streets through
audio sensors placed on light poles. The contract expired in 2021, but the sensors remained up in our district in at
least five neighborhoods. Correspondence was sent to the mayor's office demanding that the SpotShotters be
removed. As of June 11, SpotShotters are beginning to be removed from the following neighborhoods: Lincoln
Park, Skyline, Valencia Park, and O'Farrell. Councilmember Foster will continue to endorse measures that keep
our neighborhoods safe and ensure appropriate contract administration.

### Fiscal Year 2024 Capital Improvement Program Year-End Review



On May 22, the Active Transportation and Infrastructure Committee voted on the Fiscal Year 24 Capital Improvement
Program Year-End Budget Monitoring Report and Capital Improvement Project Budget Revisions. The report presents a
semi-annual review and monitoring overview of the City's Capital Improvement Project available allocations and key
funding source activity. Councilmember Foster amended the motion to exclude closing the Market-Euclid Street Pitta
Improvement Project. This amendment ensured that the project which would provide safety enhancements along the
Emerald Hills and Valencia Park corridor remained open. The motion passed in committee and Council unanimously
passed the item on June 11.

### **Appointment of New Police Chief**



• On May 13, Scott Wahl was appointed as the new Chief of Police. Upon first being nominated Coucilmember Foster expressed apprehension on the hiring process and the commitments expressed by the candidate. He voted to not support this appointment. Councilmember Foster met with the candidate on several occasions to discuss the expectations our community has for this role and the work he needs to provide for public safety. He committed to working on internal operations within the department, addressing racial bias in policing, working with the commission on police practices, and violence interruption alternatives like the No Shots Fired program. Following the conversations, Councilmember Foster agreed to support his appointment. He assumed office in June, following the retirement of Chief David Nisleit.

### Library Department Launches Program to Erase Library Fines and Fees for Youth



 On April 17, the Council approved a measure, Fresh Start, that would ensure accounts with outstanding library balances, for juvenile accounts, be waived. This is through the support of the Library Foundation SD, who generously pledged to pay off the accounts of the juveniles in collection. Those with accounts that had previously been sent to collections will have the opportunity to work with library staff to bring their accounts back to good standing.

**Pavement Management Plan** 



On April 9, City Council heard an informational item on the Transportation Department Pavement Management Plan. The plan summarizes the current city-wide street condition and identifies the strategic investment needed. While the plan provided an implementation scenario of investing \$1.9 billion over the next 10 years, it does not sufficiently improve the deteriorating streets in our district. Councilmember Foster expressed his concerns and adamantly noted that the city must create an equity centered plan that prioritizes historically neglected communities with failed streets and unimproved roads. Councilmember Foster further stated that this plan is not ready for implementation. ### Food 4 Less, Market Creek Plaza: Air Quality Testing



• In June, indoor air testing took place at the Market Creek Plaza due to a possible environmental issue: volatile organic compounds (VOCs). Specifically, inside the Food 4 Less Building. The purpose of this test is to determine whether any contaminants remain in the air from the previous owner's use of the site. Contaminants found at a neighboring location prompted the investigation and results are expected by mid-July.
