#### PARKS AND RECREATION DEPARTMENT

#### **DIRECTOR'S REPORT**

Thank you all for the opportunity to share updates within the Parks and Recreation Department. This information is typically provided to the Parks and Recreation Board each month. The following report consolidates information shared with the Board over the past several months to allow Area Committee attendees an opportunity to review the same information.

Area Committee Clearinghouse: Area Committee reform will be a part of this effort. In recent experience, the meetings have been all information sharing with few action items and difficulty securing a quorum. One option may be to create a standing, online/virtual workshop to allow Community Recreation Group members to receive information directly from Department leadership on topics of shared concern, such as budget development, recreation center funds, recreation equity, fees and charges, process improvements, and similar topics.

## **Budget Update:**

- On June 11, 2024, the City Council adopted the Fiscal Year 2025 budget. The approved budget, which was signed by Mayor Gloria on June 14, 2024, includes:

- Some additional changes occurred in IBA Report 24-14 and Resolution R-315627 that impact the Parks and Recreation Department. Those include:
  - Add \$1 million in capital funding to project P-24002 to improve Officer Jeremy Henwood Memorial Park in City Heights
  - Transfer \$500,000 in Infrastructure Fund from Project P-20005, Chollas Triangle Park, to a new project, Southcrest Recreation Center and Park Drainage Improvements (feasibility study stage)
  - Add \$500,000 in Citywide Park Development Impact Fees to Project P-20005, Chollas Triangle Park
  - Add Climate Equity Funds to the following projects:
    - S-22002 Grove Neighborhood Park: \$4,505,720
    - B-22045 Hardcourt Improvements at Emerald Hills Park and Encanto Community Park: \$800,000
    - B-23011 Willie Henderson Lighting: \$350,000
    - S-00752 Beyer Park Phase 1: \$216,680
    - B-20060 Chicano Park Improvements Phase III: \$48,000
  - Reduce \$1,498,000 for new facility fleet acquisition and shift that activity to debt financing under the City's Equipment and Vehicle Financing Program (EVFP)
  - Reduce \$974,000 by delaying the start date for Parks and Recreation Open Space environmental initiatives and San Diego River Park Rangers to January 1, 2025 (see memorandum from Director Field dated June 14, 2024, linked at <a href="https://www.sandiego.gov/sites/default/files/2024-06/proposed\_fiscal\_year\_2025\_open\_space\_additions.pdf">https://www.sandiego.gov/sites/default/files/2024-06/proposed\_fiscal\_year\_2025\_open\_space\_additions.pdf</a>, for more information)

 Reduce \$724,000 for water expenditures given under-budget performance in Fiscal Years 2023 and 2024 (between \$2.7 and 3.1 million in savings each year)

<u>Childcare Updates:</u> The Office of Child and Youth Success (OCYS) is continuing to look at increasing childcare opportunities Citywide, including exploring options for childcare offerings in local parks. Their work is divided into three main areas:

#### Measure H Implementation (licensed childcare):

- Current prioritized locations for licensed childcare:
  - Southcrest use inactive Teen Center.
  - Memorial use prefabricated modular building on park space.
  - o Mountain View use prefabricated modular building on park space.
  - Encanto use prefabricated modular building on vacant lot on south side of Wunderlin Street across from recreation center.
  - Linda Vista use prefabricated modular building on park space.
- The OCYS is seeking funding to upgrade facilities or purchase and install modular buildings.

## **STEM Pre-Kinder Programs (license-exempt)**

- Parks and Recreation Department plans to issue Request for Statement of Qualifications (RFSQ) to solicit community providers to operate programs under the Citywide Recreation Services Division.
- Programs would operate in a shared space arrangement in recreation centers.
- OCYS is seeking funding to be able to provide programs at identified sites that are free/low cost to families (priority locations same as above for Measure H).

## Outdoor Nature Recreation Programs for Pre-Kinder Children

 City Attorney's Office recommends a Right of Entry Permit for programs to operate.  OCYS will work with Parks and Recreation Department to develop permit and outreach to community operators.

OCYS will request to present to Community Recreation Groups at above prioritized sites in the few months to share general information and get feedback about childcare needs in their communities as well as preliminary planning considerations for programs.

#### **Community Recreation Groups and Council Policy 700-42 Reform:**

Preparations for an update to Council Policy 700-42 for Community Recreation Groups is still under development. Public input on the draft policy would include a workshop here at the Parks and Recreation Board and at the Area Committee, with the possibility of an ad-hoc committee for additional review and comment as needed.

#### **Parks in the News:**

• Parks After Dark returns for a third summer: On June 13, 2024, NBC 7 reported that the Parks and Recreation Department and San Diego Parks Foundation have offered Parks After Dark at five locations over an eightweek period. It started in 2022 with three parks and has grown each year since. This year, it has been held at City Heights, Linda Vista, Memorial, and Skyline Hills parks from June 20 through August 17, 2024, and Silver Wing from June 20 to July 27, 2024. This popular program transformed five neighborhood parks into evening community festivals every Thursday, Friday, and Saturday night. Highlights include health and fitness activities, music, movies, arts and crafts, games, youth sports clinics, tournaments, resources from non-profit organizations, and free food for children.

Parks After Dark is based on a Los Angeles County program run every summer for more than a decade. According to data provided by the San Diego Parks Foundation, the first three parks to host similar programs in Los Angeles saw a 32% decrease in serious and violent crimes within their first three years, between 2009 and 2013. 
• Skate Park near Porter Elementary School: On June 16, 2024, the San Diego Union-Tribune reported on a proposal from Manuela Ippolito, a fifthgrade teacher at Porter Elementary School, to build a skatepark on privately owned property on the west side of 47<sup>th</sup> Street adjacent to Interstate 805, with a possible second option at Chollas Community Park. Ms. Ippolito organized youth to call attention to the need for a skate park in the vicinity of Porter Elementary School, and she has been in touch with local advisory bodies, the City Councilmember's Office, the Mayor's Office, and the Parks and Recreation Department to learn more about the City's capital program and the public input process. The preferred choice for a skatepark is not owned by the City, no public workshops have been conducted, and there is no project funding currently. #### **Parks Master Plan Updates:**

- Blueprint SD/General Plan Refresh: On July 23, 2024, the City Council voted unanimously to adopt Blueprint SD, a refresh of the General Plan, intended to create an equitable and sustainable framework for growth to support current and future San Diegans. Blueprint SD identifies areas for more homes and jobs that are connected to convenient and affordable options to walk/roll, bike and take transit to meet daily needs, such as going to work, school, parks, restaurants, and grocery stores.
- Chollas Creek Watershed Regional Park Master Plan Update: The Chollas Creek Watershed Regional Park Master Plan effort is underway with the following goals:
  - o Protect and enhance the Chollas Creek Watershed's ecology.
  - Improve the watershed's sustainability and resilience to the impacts of climate change.
  - o Increase recreational opportunities.
  - Improve walking/rolling and biking within the watershed and adjacent to neighborhoods.

 Foster a sense of ownership and connection to Chollas Creek among community members.

- o Public Workshops and Pop-Up Events additional events
- Existing Conditions Report City Planning is examining the Chollas
   Creek Watershed's physical and social infrastructure to help map areas

- of interest, identify recreational opportunities, and better understand needed improvements.
- First Draft Master Plan City Planning is developing the draft watershed master plan.
- Equity Forward: The Environmental Justice Element (see <a href="https://www.sandiego.gov/sites/default/files/2024-05/ej-element-draft.pdf">https://www.sandiego.gov/sites/default/files/2024-05/ej-element-draft.pdf</a>) was approved by the City Council on Monday, July 1, 2024. The Environmental Justice Element is intended to advance the equitable distribution of benefits and limit environmental burdens to promote healthy and livable communities for all San Diegans. The Environmental Justice Element includes goals that envision a more equitable future, policies that inform City decision-making, proposed activities that build on existing programs to advance environmental justice, and a description of areas of the City most impacted by environmental burdens and associated health risks collectively known as Environmental Justice Communities (EJ Communities).

#### • Community Plan Updates:

- Hillcrest Focused Plan Amendment: On July 30, 2024, the City
  Council voted to adopt the Hillcrest Focused Plan Amendment, which
  includes housing and development strategies intended to strengthen
  the Hillcrest business district and bring neighborhood benefits where
  they are needed most. The approved plan and supporting documents

- University Community Plan Update: On July 30, 2024, the City
  Council voted to adopt the University Community Plan Update, which
  serves as the 30-year vision for land use, mobility, urban design, public
  facilities and services, natural resources, historic and cultural
  resources and economic development in the University Community
  Planning Area. The approved plan and supporting documents are
  available at PlanUniversity.org.
- Mid-City Communities Plan Update: The City of San Diego is updating the Mid-City Communities Plan for the first time in 25 years to identify opportunities for new homes, businesses, and

infrastructure to benefit everyone in Mid-City. The Draft Mid-City Atlas: Existing Conditions Report was recently released online and feedback is welcome at PlanMidCity@sandiego.gov. - College Area Community Plan Update: City Planning staff is continuing to work on a discussion draft of the College Area Community Plan Update. A discussion draft is anticipated to be released this fall, and the City Planning Department looks forward to hearing additional feedback from community members. - Clairemont Community Plan Update: City Planning staff continues to work on a discussion draft of a revised draft Clairemont Community Plan, incorporating input from the wider community and the Planning Commission. • **Trails Master Plan**: On July 15, 2024, the City Planning Department launched a new webpage (<a href="https://www.sandiego.gov/planning/citywide-trails-master-plan">https://www.sandiego.gov/planning/citywide-trails-master-plan</a>) to engage with community members on the Citywide Trails Master Plan.

As part of Equity Forward (<a href="https://www.sandiego.gov/equity-forward">https://www.sandiego.gov/equity-forward</a>) and as identified as a key implementation action within the Parks Master Plan (<a href="https://www.sandiego.gov/planning/parks-master-plan">https://www.sandiego.gov/planning/parks-master-plan</a>), the Citywide Trails Master Plan (Trails Master Plan) will guide the provision and enhancement of open space multi-purpose trails that serve pedestrians, hikers, bicyclists, mountain bikers, and equestrians.

**Recreation Programs:** Summer programming continues. Many sites are hosting summer camps, and the Department is hosting popular Come Play Outside, Parks After Dark, and Teen Nite programs at several sites.

#### **Sidewalk Vending Ordinance (SVO):**

On February 27, 2024, the City Council passed Ordinance O-21775 to amend the SVO to address expressive activity, sidewalk vending impoundment, and make technical changes to align SVO with State law and other sections of San Diego Municipal Code. Expressive activity is defined as follows:

## "Pure speech" protected by the First Amendment includes:

- Speaking on a street corner or in a park about a political, ideological, or religious topic
- Distributing brochures
- Art sales and art creation, including paintings, caricatures, balloon animals, sculpture, and other visual arts sold by the artist
- Street performances/busking
- Face painting or henna tattoos
- Distribution or sale of books, music, paintings, photographs, sculpture or CDs or recordings created by the person selling the items

Examples of activities that are not considered "pure speech" include:

- Sales of handcrafts like jewelry and pottery
- Sales of personal care products, including makeup, lotion, perfume, incense and incense burners
- Sales of mass-produced items, including clothing and hats
- Food sales
- Teaching exercise, yoga, or dog training classes
- Hair braiding, massage, application of skin care, makeup, or other products

The SVO amendments include general time, place, and manner rules that would apply to anyone engaged in protected First Amendment speech on City property, including a space limit similar to the 24 square foot limit applicable to sidewalk vendors, a prohibition from using or attaching equipment to City property, including City utilities, and display and setup provisions to ensure sidewalks and walkways are passable and safe for all people to use.

The sound level limit between 7 a.m. and 7 p.m. is 65 decibels, and the sound level limit between 7:01 p.m. and 6:59 a.m. is 55 decibels.

Staff is currently working to designate expressive activity areas in parks, plazas, and high-traffic areas that are available on a first-come, first-served basis, to persons who desire to use equipment, including a table, easel, stand, chair, umbrella, sunshade, or other furniture as part of their expressive activity. Such high-traffic parks include most shoreline and beach areas as well as Balboa Park. These locations are being developed and vetted currently.

Anyone who is not engaged in protected speech activities but is selling items on public property is a sidewalk vendor and thus must comply with the SVO. Park Ranger Chief Michael Ruiz is the lead point of contact on this matter for City Parks.

### **Employees of the Quarter:**

The Parks and Recreation Department is proud to announce the employees of the quarter for the fourth quarter of Fiscal Year 2024:

- Fabian Alvarez, Swimming Pool Manager I, who has consistently
  demonstrated exceptional dedication, professionalism, and exemplary
  performance in his role. Fabian works at the Bud Kearns Pool and despite the
  high volume of activity at this pool, Fabian excels in training and mentoring
  new staff members while operationally serving as the key leader
  simultaneously overseeing a wide variety of programs and activities.
- Ulises Alvarez, Tree Trimmer, who greets everyone with enthusiasm every
  morning and approaches tasks with a can-do attitude; is consistently willing
  to lend a hand, even beyond his designated responsibilities; and willingly
  takes on additional projects. He is a great asset to the Park Forestry Unit as
  his abilities, tree worker certification skills play a crucial role in trimming
  trees to limit and eliminate potential safety hazards. He encourages and
  motivates others to maintain a positive mindset, even when the workload
  becomes overwhelming.
- **Issac Avila**, Recreation Aide, who creates a fun, interactive, and a safe environment at the South Clairemont Rec Center. He excelled in managing a new soccer class, increasing attendance, and guiding it to success. Issac also took the initiative to start the first soccer skills class and going above and beyond in promoting it to the community. He began with five children and grew the group to 15. He helps children learn new sports techniques and basics of sportsmanship, is always eager to learn and demonstrates strong leadership skills by taking on additional responsibilities.

- Roberto Bejar, Senior Park Ranger, who had the challenging task of forming and mentoring a brand-new Ranger team dedicated to navigating and enforcing the new sidewalk vendor and expressive activities ordinances. The task was extremely difficult given the huge pushback, confrontation, and high level of abusive rhetoric while he and his team remain calm, respectful, and extremely professional. He represents the best in how public servants should interact with the public, professional, intelligent, and fair.
- Mark Berninger, Senior Planner, who during the Fiscal Year 2025 budget development process was an integral part of building out the number of positions, tasks, and supporting documentation to request 12 positions for the Open Space Division. Worked closely with management and analysts to construct priority adds, which resulted in packages that included Park Rangers, Biologists, administrative, and grounds maintenance staff. Mark was the subject matter expert during the budget hearings, which later resulted in the City Council approving all 12 positions which is a huge win for the Division.
- Valentin Briones, Grounds Maintenance Worker II, who is a fantastic employee. He is responsible for the maintenance of Cesar Chavez Community Center/Larsen Field and all its amenities and is the San Ysidro area parks rover on the weekends. When there are teamwork projects, he doesn't hesitate to assist, or to fill in when another GMW is off. He receives compliments from park users for the cleanliness, well maintained, graffitiless, and for how safe it feels to use the park with their families which is demonstrated by the lack of Get it Done and Ask Parks inquiries regarding his sites.
- **Sidney Michael, Jr.,** Recreation Leader I, who is the soul of Standley, the whole community knows him, and the kids respect him and obey him at the same time. He's a great worker and does his job very professionally and on time. He goes above and beyond when he has a job that is important to the community. He provides wonderful customer service, answers the phone very courteously and helps with special events and programs. He is also a reliable staff member in all aspects of building maintenance.

- Tan Nguyen, Utility Worker II, who brings a lot of knowledge to the Hardscape Facility Repair and the Playground Unit. He recently acquired his class B commercial license, with the intention of balancing the workload among team members. He demonstrates humility and a willingness to prioritize others over himself. Tan is a veteran employee with a young and humble heart, always going beyond his regular duties and took the initiative to train new staff on repairing the pour in place surfacing. Tan encourages others to maintain a positive attitude; Tan is a true example of a model public servant.
- **Erika Weikel**, Senior Park Ranger, who continues to excel in her position which oversees over 3,000 acres of open space canyons; had two volunteer habitat restoration events, focusing restoration in underserved communities (150 plants); two volunteer trash cleanups with I Love a Clean San Diego (3,500 lbs removed); presented a PowerPoint on the duties of an Urban Park Ranger to 300 students at the annual Careers in Public Service; hosted a booth at the Rotary Club Earth Day event to connect interested parties in future volunteer opportunities; and assisted an unsheltered woman who could no longer care for the dog she had found. Erika volunteered to find the dog a new home, but when it was discovered that the dog was chipped, it led to reuniting the dog with its original owner.
