# Seamus Kennedy, Community Rep. for District 2 CM Campbell:

- Street Vendor Ordinance enforcement will be by Police & Park Rangers
- Park Ranger new hires will not be hired until July 2025, cut from budget

- Jessica Thrift is the North City SDPD rep and answers questions at the MBTC meetings
- 2<sup>nd</sup> Trash pickup will be in effect all summer 2024
- CIP is fund for 50 yrs. OB Pier and PB Lifeguard tower got funded
- \$30M funded for sewer pipes in So, Mission Beach, got \$32M from Feds

## Cole Reed, 39th Senate District Rep, Office of Senate President Pro Tempore Toni G. Atkins

- Three Bills of Ms. Atkins were passed SB 1428 -reproduction, SB 1213 Breast Cancer support for low income, SB 1342 San Vicente pump station maintains energy via dam water
- Mr. Reed was interested in understanding the MB- PDO requirements that differ from what San Diego City Planning Staff approve for ADUs. This difference puts the MBPPB in confusing positions when reviewing plans. The Board needs answers on what is allowed, legal in MB and what is not.
