Whereas, the stand taken by the Common Council will involve an unnecessary and enormous expenditure of money, which will have to be born by the tax payers moreso than the eighty-five good citizens who are so desirous of having the poor people oppressed, and

Whereas, Organized Labor has always been on record for the freedom of speech and press, and strictly opposed to the oppression of the working people by a chosen few, therefor be it

Resolved by the San Diego County Federated Trades and Labor Council in regular meeting assembled that we go on record condemning the action taken by the Common Council of the City of San Diegoin passing an ordinance prohibiting Free Speech on our streets, and be it further
