Presentation: Trees for Communities Update

- City's Urban Forestry Program maintains 250,000 to 600,000 street trees.
- Trees for Communities program has \$4.6 million in funding. City has recently received \$10,000,000 in funding from the U.S. Forestry Service for its Ready, Set, Grow campaign. U.S. Forestry grant includes funding for LIDAR (Light Detection and Ranging) analysis.
- Beginning in April 2024, the Urban Forestry Program has planted 816 trees, held 14 community meeting regarding tree planting, and conducted 9,000 waterings.
- There are 12,479 trees in the Promise Zone and 2,037 vacant sites where trees can be planted. Promise Zone had 13% tree canopy cover in 2014.
- City Council approved LIDAR tree analysis in May. LIDAR analysis requires a large amount of computing power, which is why data is being sent to vendor to process and return to City by the end of the year. Once data is returned will be able to compare tree cover with 2014 data. City's goal for tree coverage is 35%.

Presentation: Nutrition Insecurity in Promise Zone

- Success for San Diego Hunger Coalition (SDHC) means there is No Meal Gap. Meals provided should be culturally appropriate.
- Meal Gap = (Total Meals Required by At-Risk Population) (Self-Purchased Meals) (Food Assistance)
- Food insecurity is based on self-reported data, while nutrition insecurity isn't.
- Measure used by SDHC is 200% of federal poverty level.
 - Ex. Single member households that make under \$30,120 are considered nutrition insecure, while a family of four that make under \$62,400 are considered nutrition insecure as well.
- Since June 2022, nutrition insecurity in San Diego has increased 2%, from 23% to 25%.
- In Promise Zone, Census tract 50 is experiencing a 61% meal gap and tract 51.03 is experiencing a 77% meal gap. <u>Link to Census Tracker here</u>
- 55% of meal assistance in San Diego is CALFresh, while school-provided meals make up an additional 26%.
- Enrollment for CALFresh is higher in Promise Zone (80%) than San Diego County (65%)
- Overall, the hunger sector (e.g. CALFresh, Food Banks, etc.) covers 88% of the meal gap in Logan Heights (90,000 out of 116,000 total). In Area Code 92101, it provides 67,000 meals, and in 92102, it provides 19,000.



- 80% of those eligible for CALFresh are enrolled, but 3,970 people who are eligible haven't managed to enroll. *If these 3,970 people enrolled, the 163,000 meals added would close the meal gap in Promise Zone.*
- In the future, the San Diego Hunger Coalition is looking to increase its measurement from 200% to 215% (Posted as answer to question in chat).

- **Bex** is currently creating brochures for victory gardens, and will follow up with Diane Moss on growing spaces.
- 2.1.2 (marketing plan) and sub-activities will be updated.
- Karen: How can the organizations present support this work?
- **Rachel**: Any leadership training + resources, different channels, advocacy list, community newsletter/relations that any resource can go through, coordinated community engagement (tabling @ socials), flyers + resources, Rachel's willing to share!
- **Joseph**: Same sentiments with them, have 2-3 newsletters we can collaborate on.
- **Amber** received an email from a community member who would like to start a community garden, but the property identified is in the right-of-way.
- 3.1.6, Meet with Food Justice Action Plan, was added. Meals on Wheels interested on working towards this objective.

Group 2: Support Opportunities for Active Transportation and Active Living (<u>view Objective 3</u> <u>Logic Model here</u>)

- **Brian:** City conducted Tree Inventory in 2018 and 2021 2022. Looking for areas where concrete can be removed, and trees planted. Public document contains information on survey of potentially plantable areas. Documents may not be up to date as things change quickly in 2 years. Areas not benefited by EHC planning grant still require trees.
- Zach: Can we join up with GIS mapping person to not duplicate efforts?
- **John:** CGI is contractor that the Urban Forestry Dept. is working with, and their in-house GIS specialist is Kevin. It takes time to sync new LIDAR data with City operating software. At the moment, they can only share mapping data as CSV.
- **Zach**: One of the Logic Model activities is to connect with Groundwork, is there overlap?
- **Brian, John:** Tree King is Thad Winkle at Groundwork San Diego. Trees for Communities and Ready, Set, Grow programs overlap with areas that Groundwork already works in. Urban Forestry is focused on Street Trees and City Parks, while Groundwork is thinking



- about planting trees on Private Property. Looking to collaborate with Groundwork in the future about the Trees for Community and Ready, Set, Grow campaigns.
- **Anne:** GIS intern from SDSU is about to start. Wants to re-convene Tree Mapping Group. Can meet on Zoom intermittently on a separate schedule from Working Group.
- **Brian:** EHC is planting more than the 700 trees identified on website.
- Craig: Presented a proof of concept for Chollas View from Encanto Planning Area that
 they are planning to add trees meets the City's criteria for street right-of-way and
 CALEnviro standards. 30% tree canopy coverage is City minimum, but only 4 out of 297
 parcels currently meet that threshold. No need for LIDAR as existing mapping data will
 suffice for tree planting program.
- **Brian:** Would like access to Kate Session's mapping data as it will assist them with tree planting especially when placing trees on the back of right of way streets. Trees placed on backside of right of way have a risk of falling into yards rather than the roadway.

- **Lizzie:** Can coordinate/facilitate tree planting efforts in the San Ysidro area.
