COMMISSION ACTION:

MOTION BY BUTLER TO CERTIFY THE MITIGATED NEGATIVE DECLARATION AND APPROVE CONDITIONAL USE PERMIT AND RESOURCE PROTECTION ORDINANCE PERMIT 95-0362, SUBJECT TO CONDITIONS (ATTACHMENT 3), ALONG WITH THE ADDITIONAL CONDITION DISTRIBUTED TO THE COMMISSIONER'S AT THIS HEARING FROM STAFF REGARDING A NEW BUS STOP. STAFF WAS ALSO DIRECTED TO COME BACK TO THE COMMISSION WITHIN THE NEXT FEW WEEKS, WITH INFORMATION ON CONDITION NO. 23, ATTACHMENT 3, PAGE 5 OF 5 REGARDING THE AGE OF OCCUPANTS. THE NUMBERING OF THE CONDITIONS WILL ALSO BE CORRECTED ON THIS SAME PAGE. ITEM-6: PROPOSED NORTH BAY REDEVELOPMENT SURVEY AREA.

Pat Hightman and Mike Stepner presented Report to the Planning Commission No. P-96-102.

Testimony in favor by:

Keith Webb, Chair of Midway Community Advisory Group and property owner. Advised he is in favor of this plan as the Chair of the community group, but against it as a property owner. He lives within the North Bay Redevelopment area. He feels that if this is a desire on the part of the City to upgrade the entire area, then they will support it; if this is just a ploy to identify those taxes to justify revenue bonds then it is a fraud, and cruel. He opposes using tax money in any way that will not improve the entire area.

Public testimony was closed.

MOTION BY WATSON TO RECOMMEND APPROVAL TO THE CITY COUNCIL OF THE BOUNDARIES AS PRESENTED BY STAFF WITH THE ADDITION OF THE CORNER OF LINDA VISTA (MORENA BOULEVARD SOUTH IN CLAIREMONT), AND WITH THE ADDITION RECOMMENDED BY COMMISSIONER SKOREPA TO INCLUDE THE COMMERCIAL PORTION OF OLD SAN DIEGO. Second by Quinn. Passed by a 6-0 vote with Vice-Chairperson Anderson not present.
