ITEM-1: CONSIDERATION OF THE DRAFT FISCAL YEAR 1997 CONSOLIDATED ANNUAL PLAN.

COMMISSION ACTION:

MOTION BY WATSON TO ADOPT THE STAFF RECOMMENDATION WITH THE FOLLOWING INCLUSIONS: 1) POLICY STATEMENTS IDENTIFYING AREAS IN THE CITY WHERE TOXIC ENVIRONMENTAL CONDITIONS ARE HAVING A NEGATIVE IMPACT; 2) POLICY STATEMENTS TO IDENTIFY SOLUTIONS FOR THE PROBLEM AREAS INCLUDING COSTS AND RELOCATION OF INDIVIDUALS AND/OR RESIDENCES; 3) AREAS WHERE OUTDATED COMMUNITY PLANS (AND ANY OTHER DOCUMENT PERTAINING TO THAT AREA) ARE HAVING A NEGATIVE IMPACT ON HOUSING SHOULD BE IDENTIFIED AND THESE PLANS SHOULD BE UPDATED AS A RESULT; 4) THAT THE CONSOLIDATED PLAN MAKE REFERENCE TO ALL THE REDEVELOPMENT AREAS THAT ARE CURRENTLY IN THE CITY OF SAN DIEGO; 5) THAT THE CONSOLIDATED PLAN MAKE APPROPRIATE REFERENCES TO PROVIDE SERVICES COMMUNITY WIDE WHEREVER POSSIBLE. Second by Butler. Passed by a 5-0 vote with Chairperson Neils and Vice-Chairperson Anderson not present.

ITEM-2: WORKSHOP - NORTH CITY FUTURE URBANIZING AREA AFFORDABLE HOUSING REQUIREMENT - PROPOSED IN-LIEU FEE OPTION FOR SMALLER DEVELOPMENTS.

ITEM-3: PUBLIC HEARING REGARDING HOUSING TRUST FUND PROGRAMS FOR FISCAL YEAR 1997.

Discussion held. No action taken by the Planning Commission. This public hearing was used to develop a draft Fiscal Year 1997 Three-Year Plan and Implementation Strategy which will then be presented to the Housing Commission for approval.
