6 a-Measure B-Trash Collection fees study (Anna Griffin) Cost-of-Service Study on the implementation of Measure B. The study will examine new fees for trash and recycling services for single family homes. Measure B was passed by voters in 2022. It amended the People’s Ordinance to allow the City to study fees for trash collection from single family homes. In response to the vote, the City is starting a public process to evaluate its trash and recycling services. The study will review: Options for new or enhanced services and costs for the options, and ways for the City to get paid for its services, and accommodations for low-income residents.

New fees would apply to single-family homes and lots with four units or less that are served by the City.
