ITEM-2: APPROVAL OF THE MINUTES OF FEBRUARY 22, 1996.

COMMISSION ACTION:

MOTION BY WHITE TO APPROVE THE MINUTES OF FEBRUARY 22, 1996. STAFF WAS DIRECTED TO BRING BACK A SEPARATE MEMORANDUM IN TWO WEEKS, ADDRESSING THE THREE SIGNIFICANT AREAS OF CONCERN, I.E., POLICY NO. 9 FEDERAL AND STATE POLICY FUNDING; POLICY NO. 14 BRUSH MANAGEMENT; AND NEIGHBORHOOD 8A, EXPLAINING THE COMMISSION'S RATIONALE FOR THEIR ACTION TO THE CITY Second by Quinn. Passed by a 6-0 vote with Commissioner Butler abstaining as she was not at that meeting.

ITEM-3: INITIATION OF AMENDMENTS TO THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AND PROGRESS GUIDE AND GENERAL PLAN AND THE SOUTHEAST SAN DIEGO PLANNED DISTRICT ORDINANCE (NORTH CREEK AND HILLTOP SITES).

> Coleen Frost presented Report to the Planning Commission No. P-96-063.

Testimony in favor by:

John Johnson, President, San Diego Urban League. He feels that the Community is asking that the City delay this study, but we feel that they can't delay this any longer. The Planning Commission should initiate this study so that we can look at all the vacant land that exists in this area. The Urban League itself sits in the middle of a lot of this redevelopment area. They are aggressively seeking to develop housing, and this project should be included for this development.

Carol Foster, San Diego Urban League, Director of Housing. Comments related specifically to the Hilltop site. Good planning is planning for a balanced community which includes quality services for the benefit of surrounding neighborhoods and individuals. This zoning will only benefit the planning of this balance.

Testimony in opposition:

Reynaldo Pisano, SESD Development Committee. Read a letter from Anna Major into the record. Spoke to a complete analysis of the project area, economic analysis as the Lucky's shopping center will have a substantial impact on this area, retaining the underlying zone, scheduling design charrettes, and requested that no land use designation changes be done until the results of the impact studies and economic analysis can be returned to the Committee.

Mary Braswell, Chollas View Neighborhood Council.
Stated that they oppose this project; they have opposed it for thirty years. There will be tremendous traffic impact if this project is approved. The traffic patterns would have to be changed to accommodate this shopping center. Why put a shopping center in an area that you can barely travel now. It is just too concentrated already and we don't need a shopping center there.

Bobby Jones, homeowner. Spoke to the traffic impacts as well and the crowded area; and the strong possibility of property devaluation.

Michael Mathis, neighbor. Also spoke to the traffic issue and the school concerns with children having to cross congested streets in this area. Figures show that there are 36,000 cars per day now in this area, and this project will only increase that amount

significantly. Feels his property, too will be devalued due to vacant buildings in this area and the heavy traffic. Wants to have this study done as he feels it will only work in their favor.

Public testimony was closed.

STAFF WAS ALSO DIRECTED TO PREPARE AN ECONOMIC IMPACT ANALYSIS AS PART OF THE INITIAL STUDY. Second by Anderson. by a 6-0 vote with Commission Butler abstaining.

Doug Boyd, T&B Planning, representing applicant. is a relatively minor and simple initiation for a community plan amendment. Mr. Boyd stated that they are in agreement with the staff analysis that this initiation does meet the four criteria listed.
