The Transportation and Special Events & Filming Departments will share the proposed fee for installation of permanent “No Park” signage within the public right-of-way for reoccurring Special Events.

Item 5: STAT Team Update (Information) – 4:20 pm estimated
The Transportation Department will provide a STAT update. STAT is responsible for the design and installation of new or upgraded bicycle facilities to compliment larger projects throughout the City. Planned work includes quick-build projects, detectors and other signal enhancements, and layout and installation of bicycle and pedestrian facilities which could include additional striping, bollards, legends, and signage.

Item 6: Public Right-of-Way Transition Plan Phase I (Information) – 4:45 pm estimated

The Sustainability and Mobility Department will provide an update on the Transition Plan which will identify, map, evaluate, and prioritize remediation of accessibility-related elements in the ROW in communities south of Interstate 8. Elements include curb ramps, major obstructions in the path of travel, audible pedestrian signals, and parking spaces designated for people with disabled placards or license plates. Phase two consists of communities north of Interstate 8; that project will begin in approximately two years.

Item 2: Approval of Meeting Minutes (Action)

Item 4: Draft City of San Diego Zero Emissions Vehicles Strategy (Information)

The Sustainability and Mobility Department led a discussion about work efforts related to the Zero Emission Vehicle Strategy.

There were no public comments received. The Mobility Board shared an interest in these initiatives and discussed the need for more information via the City's website, equitable distribution of chargers throughout the City, the need for coordination with MTS and SANDAG for more grant dollars, and need for coordination with SDG&E for installation.

Item 5: Bike Master Plan Update (Discussion)

The Sustainability and Mobility Department led a discussion about work efforts related to the Bike Master Plan Update.

There were no public comments. Board shared that an additional equity analysis should be done to ensure that routes are planned throughout the City, that the current outreach be shared with the Council Districts directly, that all data resources be considered in the development of the Plan, and that more outreach be done. Board members offered to share with their various connected groups

Subject: Requests for Fiscal Year 2026 Budget

Dear Mayor Gloria and Councilmembers,

We are writing on behalf of the City of San Diego Mobility Board to propose recommendations for the FY 2026 budget cycle of the City of San Diego. We appreciate the leadership that you have shown in developing safe and sustainable mobility options. We emphasize the importance of prioritizing mobility investments for historically underserved communities of concern. We look forward to continuing to work together to build a truly multi-modal system in San Diego.

In alignment with our overarching objectives of equity, safety, and climate action, we are proposing a list of citywide mobility priorities for inclusion in the Fiscal Year 2026 budget cycle:

Citywide General Priorities

Addressing the Deficiency of Pedestrian Infrastructure:

Prioritize the enhancement of pedestrian infrastructure and safety in the Fiscal Year 2026 budget. This includes updating and fully implementing the Pedestrian Master Plan (2006), with a focus on areas lacking sidewalks. Well-maintained sidewalks are essential to Vision Zero goals, and the City should increase funding for sidewalk repairs and new installations. Further, we propose the development of a policy framework for pedestrian boulevards and pedestrian-only corridors, emphasizing lighting, shade, and seating to ensure safety and comfort for pedestrians and public transit users. Additionally, funding should be allocated for new streetlights and tree planting, supporting the 2022 Climate Action Plan goal of planting 40,000 new trees by 2030 in Communities of Concern. Investments in fixing the most dangerous intersections, as identified in the Systemic Safety Analysis Report Program, should focus on cost-effective safety measures like lead pedestrian intervals, countdown timers, high-visibility crosswalks, curb extensions, and roundabouts. Lastly, the City should establish a Healthy Commuter Incentive Program to promote sustainable and active commuting for City employees.

Addressing Missing Links in the Bike Network:

Item 7B

Prioritize off-cycle resurfacing to complete essential bike network connections on dangerous roads and allocate funding for full-build bikeways during resurfacing. This will improve the bikeway network efficiently in key areas of San Diego. Strengthen parking and code enforcement in bikeways, particularly in the urban core, by assigning two parking enforcement officers to curb illegal parking and parklet encroachments. Utilize the NACTO Urban Bikeway Design Guide as the standard for new bike facilities, aligning with the city's goals and the latest safety classifications. Restore funding for Vision Zero education programs and support active transportation campaigns. Fund the implementation of Leading Pedestrian Intervals (LPI) on slow streets and explore lowering speed limits on Vision Zero Corridors using AB 43 legislation. Continue funding the Safe and Sustainable Transportation for All Ages and Abilities Team (STAAT) to expedite quick-build and protected bikeways, supporting Climate Action Plan and Vision Zero goals.

Transit and Micro Mobility Improvements

Transit-only lanes have the potential to transform bus routes into the most efficient transportation option. The City should study and implement transit lanes on its most congested corridors. Prioritize funding for immediate transit solutions benefiting low-income communities, including flexible fleet programs, youth opportunity passes, and expanded bus routes and service frequency. Enhance connectivity to major transit stations by investing in pedestrian and bicycle infrastructure and supporting transit-oriented developments. Collaborate with SANDAG, MTS, NCTD, and local jurisdictions to improve connectivity and accelerate the development of mobility hubs, including bikeshare, scooter programs, and EV shuttles.
