San Diego Cyber Clinic Receives \$1M in Grant Funding

[Cyber Center of Excellence \(CCOE\)](#), [California State University San Marcos \(CSUSM\)](#), [National University](#) and [San Diego State University \(SDSU\)](#) have been selected to receive \$1 million grant funding and wraparound support from [Google's Cybersecurity Clinics Fund](#) to establish the San Diego Cyber Clinic. The funding from [Google.org](#), the company's philanthropic arm, is part of a \$25 million collaboration with the [Consortium of Cybersecurity Clinics](#). Cybersecurity clinics at higher education institutions provide free digital security services to under-resourced organizations, similar to how law or medical schools offer free community clinics.

The only multi-institution clinic in the Consortium of Cybersecurity Clinics with a nonprofit industry partner leading the charge, the San Diego Cyber Clinic trains students to service clients across the public and private sectors in the San Diego region. Through engagement of key industry, academic, and government stakeholders, including the City-led and U.S. DHS funded San Diego Regional Cyber Lab, the San Diego Cyber Clinic aims to grow an inclusive cyber workforce, increase digital security for all and serve as a model for regional collaboratives. Upcoming Grant Funding Opportunities

If your organization is looking for cybersecurity grant opportunities, there are several grant application deadlines coming in the next few months.

State and Local Cybersecurity Grant Program (SLCGP)

- A nationwide cybersecurity grant opportunity, administered locally by each State agency according to the state agency's uniquely designed statewide cyber plan ([click here](#) for CA's cyber plan). In CA, the grant is overseen by the Governor's Office of Emergency Services (Cal OES) and Homeland Security & Emergency Management (HSEM) Branch.
- Eligible agencies include local and tribal government. Applicants may apply for up to \$250,000 for the 25-month performance period. There is no match requirement.
- Deadline to apply is **September 27th**. [Click here](#) for more information.

Urban Area Security Initiative (UASI)

- [Grant applications/proposals](#) must have a clear "nexus to terrorism" and must directly benefit the local region.
- Must support one of the region's overall strategy goals (goal 6 pertains to "strengthening security and preparedness across cyberspace").
- Initial submissions are due to the UASI regional goal leads by **October 4th**. Goal leads for goal #6 are Tony Ray (array@arjis.org) and Brendan Daly (bmdaly@sandiego.gov).

SD County's Community Enhancement Program (CEP)

- Funds a wide array of activities, focusing primarily on enhancements to services which promote tourism and economic development.
- Deadline to apply is **October 31st**. [Click here](#) for more information.

Cyber Lab Interest Sparked at Local Digital Government Summit

On June 27th, members of the San Diego Regional Cyber Lab's working group joined a wide range of regional public agencies to participate in GovTech's [San Diego Digital Government Summit](#). Attendees enjoyed a diverse set of panel discussions including "AI integrations in government," "Advancing Digital Equity," and "Unlocking the Power of Regional Data Collaboration." It was a successful event all around, and the Cyber Lab was lucky enough to obtain a lunchtime slot to speak to all Summit attendees about the cyber lab's most recent efforts, including the tools it has made available to the region as well as its recent release of [My eCISO](#).



The panel, consisting of Ian Brazill (Assistant Deputy Director, City of San Diego), Brendan Daly (Chief Information Security Officer, City of San Diego), and Nathan Short (Director of Information Technology, Encinitas Union School District), took the opportunity to speak about the successes and challenges of operating a regional resource like the Cyber Lab. Nathan provided details on the improvements his organization implemented within their cyber defenses through the use of

Free Cyber Security Awareness Webinar for Small Local Businesses

The City of San Diego's [Economic Development Department](#) and the [San Diego Regional Cyber Lab](#) are hosting a no-cost cybersecurity awareness webinar for small local businesses on **October 22nd from 4:00 - 5:30pm**. Many small businesses often lack the knowledge and resources to properly protect themselves from online threats and it is up to the public sector to step in and help wherever possible.

As a result, we will be working with local cyber consulting firm [FRSecure's](#) Dave Tuckman (President of [ISACA San Diego](#)) to walk businesses through the foundational steps they should take to protect themselves, their staff, and their businesses. Topics will include password management, ransomware, social engineering, and more.

The City will be offering the first 100 attendees (whose businesses are located within the City of San Diego) 1 ESET Home Security License for free. Each license will cover 5 workstations/devices in their workplace and will last for 3 years.
