Key Dates for FY 2026 Budget Development and FY 2025 Budget Monitoring

The FY 2026 Budget Development and FY 2025 Budget Monitoring calendar ("Key Dates") are prepared with input from the Office of the IBA, the Department of Finance, Engineering and Capital Projects, Public Utilities, City Planning, and Human Resources, as well as the Budget and Government Efficiency (B&GE) Committee Consultant, the Active Transportation and Infrastructure Committee Consultant, and the Director of Legislative Affairs. The attached Key Dates are based on timelines required by the City Charter as well as those established by the previous fiscal year's legislative calendar. The Key Dates include planned release dates of budgetrelated reports for both the operating and Capital Improvements Program (CIP) budgets, and their corresponding presentations to Council committees and to the full City Council.

The Key Dates calendar was reviewed by the B&GE Committee on September 11, 2024. The Committee forwarded the item to Council, with one modification: adjourning the May 15, 2025 Budget Review Committee meeting that was scheduled for review of the FY 2026 May Revision and FY 2025 Third Quarter Budget Monitoring Report and moving review of these reports to the City Council meeting on May 19, 2025. This modification provides additional time for the Council and public to review these reports after their release on May 14, 2025.

The Office of the IBA believes that the proposed Key Dates for the development and adoption of the FY 2026 budget provide numerous opportunities for input from the public and for City Council review and deliberation, while complying with all City Charter requirements. We recommend that the City Council review and approve the calendar, with any desired modifications.
