# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - Thrive Half Marathon

**COMMUNITY PLAN AREA:** Mission Bay Park, Pacific Beach

**COUNCIL DISTRICT:** 2

**LOCATION:** Ski Beach - 1600 Vacation Rd, San Diego, CA 92109

**PROJECT DESCRIPTION:** Special Event Permit for a Half Marathon & 5K run that would take place along various city streets within the Mission Bay and Pacific Beach areas (see attached maps) on November 2, 2024. The event would include run routes, stages, performances, sound amplification, tents, temporary structures, generators, fencing and/or barriers, tables, chairs, onsite food preparation, food trucks, prepackaged food, non-alcoholic beverages, portable restrooms, and recycled/trash containers. The number of total attendees is estimated at 2000. Noise associated with the event activities and set-up/dismantling would occur from November 1, 2024, at 7 AM to November 2, 2024, at 2 PM. Sound amplification would occur from 5:30 AM until 11 AM on the day of the event. Set-up would occur over two days: November 1, 2024, from 7 AM to 5 PM and on November 2, 2024, from 4 AM to 7 AM. The event would occur on November 2, 2024, from 7 AM to 12 PM, and dismantling would follow from 12 PM to 2 PM.

Ski Beach South parking lot would be closed on November 1, 2024, at 7 AM until 1 PM on November 2, 2024.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
