
Land Acknowledgment

Subject: Strong Support for High Performance Reach Code

As Chair of the City of San Diego Climate Advisory Board (CAB), I am writing on behalf of the CAB to express our strong support for the upcoming High Performance Reach Code. Passing this ordinance will demonstrate the City's leadership in reducing greenhouse gas emissions and improving resident health and economic well-being.

Background

San Diego's landmark 2022 <u>Climate Action Plan</u> (CAP) includes Measure 1.2: Decarbonize New Building Development, which targets an "All-electric reach code starting 2023 at new residential and commercial development".

After extensive stakeholder engagement, the City published a <u>Discussion Draft</u> of its proposed Reach Code in April 2023. This was put on hold due to a Ninth Circuit decision in CRA v. Berkeley regarding all-electric Reach Codes. The legal proceeding was settled in early 2024 clarifying that Reach Codes can incentivize, but not require, all electric new construction when cost effective.

Following this guidance, a number of municipalities have since adopted a High Performance Reach Code. This cost-effective approach applies to all-electric and mixed-fuel buildings alike. It encourages electrification AND provides grid/emissions benefits in projects with gas appliances. Locally in May 2024, Encinitas adopted a High Performance Reach Code.

Every 3 years, the state of California updates its Building Codes. Passing a Reach Code now will have immediate impacts and will be straightforward to update to align with the upcoming Building Code cycle which will take effect in 2026.

Recommendation

In closing, we urge you to expeditiously move forward with a High Performance Reach Code.
