# 1. Roll Call, Confirmation of Quorum, Call to Order, Welcome

# 3. Action Item:

- **a.** Approval of letter to all city councilmembers and to the mayor urging them to act as swiftly as is consistent with a major local crisis to remove from the San Diego Municipal Code Footnote 7 of Table 131-04D (§131.0443, Chapter 13, Article 1, Division 4) and to deny and halt all projects that rely on it.
- **b.** Approval of letter requesting Councilmember Foster's written position on the actions referenced in item 4a above.

- 4. Action Item: Consider enactment of a CVCPG policy to recommend denial of any proposed project within the Chollas Valley plan area that relies on Footnote 7 of Table 131-04D (§131.0443, Chapter 13, Article 1, Division 4 of the San Diego Municipal Code). This policy is based on concerns that:
  - Footnote 7 seems to have effectively rezoned areas in the Chollas Valley plan area from RS1-2 to RS1-7 circumventing the city's procedure for rezoning found in Chapter 12, Article 3, Division 2 of the San Diego Municipal Code
  - The apparent rezoning conflicts with the Chollas Valley (formerly Encanto) Community Plan.
  - Footnote 7 has significant potential to perpetuate inequitable development practices that may be violative of state and federal Equal Protection, Due Process, and Fair Housing law as well as of the Equity and Environmental Justice Elements of the city's General Plan.

Requires 2/3 of voting members in favor and must be submitted to the mayor and city attorney for approval.

- 5. Action Item: Consideration of Recommendation for PRJ-1107880/5702 Old Memory Ln / "Radio Towers" Project:" Dan Boyd and Meg Carroll presenting for D.R. Horton- Subdivision of an existing legal lot into 130 lots of 5,000 sq feet. 123 homes for sale of which 13 are income restricted.
- 6. Info Item: Special Meeting November 13, 2024, 6:30 PM: Hearing to Investigate and deliberate on report of alleged violation of Article IX of CVCPG Terms and Conditions by a CVCPG member. This member has been duly noticed and has acknowledged receipt but is not named on this agenda. (*Regular CVCPG meeting will take place on Monday, November 18 at 6:30PM*)
