PUBLIC NOTICE OF PREPARATION FOR AN ENVIRONMENTAL IMPACT REPORT AND PUBLIC NOTICE OF A SCOPING MEETING

ENGINEERING & CAPITAL PROJECTS DEPARTMENT

NOTICE OF PREPARATION: The City of San Diego (City), as the Lead Agency, has determined that the project described below will require the preparation of an Environmental Impact Report (EIR) in compliance with the California Environmental Quality Act (CEQA), which requires that public agencies consider the potentially significant adverse environmental effects of projects over which they have discretionary approval authority before taking action on those projects (Public Resources Code [PRC] Section 21000 et. seq.). According to California Code of Regulations (CCR) Title 14, Section 15064(f)(1), preparation of an EIR is required whenever a project may result in a significant adverse environmental effect. An EIR is an informational document used to inform public agency decision-makers and the general public of the significant environmental effects of a project, identify possible ways to mitigate or avoid the significant effects, and describe a range of reasonable alternatives to the project that could feasibly attain most of the basic objectives of the project while substantially lessening or avoiding any of the significant environmental impacts. Public agencies are required to consider the information presented in the environmental impact report when determining whether to approve a project.

Thereby, this Notice of Preparation of an EIR and Scoping Meeting is publicly noticed and distributed on October 1, 2024. This notice was published in the SAN DIEGO DAILY TRANSCRIPT and placed on the City of San Diego CEQA website at https://www.sandiego.gov/ceqa under the "Notice of Preparation and Scoping Meetings" tab.

PUBLIC NOTICE OF SCOPING MEETING: Consistent with Section 21083.9 of the CEQA Statutes and Section 15082 of the CEQA Guidelines, a public scoping meeting will be held to solicit comments regarding the scope and analysis of the EIR. The meeting will be held by the City of San Diego's Engineering & Capital Projects Department on **October 16, 2024,** from 6:00 to 7:30 p.m. in the cafeteria at Mission Bay High School located at 2475 Grand Ave., San Diego, CA, 92109. **Please note that depending on the number of attendees, the meeting could end earlier than 7:30 p.m.** Written comments regarding the scope and alternatives of the proposed EIR will be accepted at the meeting. Requests for translation services to offer public comment may be made by contacting <u>CIP-CEQA@sandiego.gov</u> at least two business days prior to the meeting date. The City is committed to addressing language translation requests swiftly in order to maximize public participation.

HOW TO SUBMIT COMMENTS: Comments on this Notice of Preparation document will be accepted for 30 calendar days following the issuance of this notice and must be received by November 1, 2024. When submitting comments, please reference the project name, **Mission Bay Park Improvements Program EIR**, in the subject line. Responsible agencies are requested to indicate their statutory responsibilities in connection with this project when responding. Upon completion of the scoping process, all public comments will be organized and considered in the preparation of the draft environmental document.

GENERAL PROJECT INFORMATION:

- **PROJECT NAME:** Mission Bay Park Improvements Program EIR
- COMMUNITY PLAN AREAS: Mission Bay Park, Pacific Beach, Mission Beach
- **COUNCIL DISTRICT:** 1 and 2

PROJECT HISTORY: On November 4, 2008, Proposition C was approved by City of San Diego voters. This proposition brought about an amendment to the City Charter by introducing Section 55.2. The purpose of this section is to allocate a portion of the lease revenue generated from Mission Bay Park for capital improvements within Mission Bay Park and other Regional Parks. This designated fund is known as the Mission Bay Park Improvement Fund (Improvement Fund). The Improvement Fund is utilized to carry out a series of prioritized projects outlined in City Charter Section 55.2.

To ensure proper oversight and allocation of funds, Proposition C established the Mission Bay Park Improvement Fund Oversight Committee (Oversight Committee). The Oversight Committee is responsible for supervising the prioritized project list funded by the Improvement Fund within the Improvement Zone. It also verifies that the funds are appropriately collected, segregated, retained, and allocated in accordance with City Charter Section 55.2.

The proposed project is an improvement program with specific elements to be implemented throughout Mission Bay Park, including location-specific elements. These elements align with the priority project list identified by the Oversight Committee.

PROJECT LOCATION: The proposed program is located within the Mission Bay Park Improvement Zone (Improvement Zone), as defined in City Charter Section 55.2. Regionally, the Improvement Zone is located in the westernmost portion of central City of San Diego, as shown in Figure 1. The Improvement Zone, which is comprised of approximately 164 acres, encompasses Mission Bay Park, along with additional areas in all directions; the specific extent of the Improvement Zone is shown in Figure 2. Generally, the Improvement Zone is bound by the communities of Pacific Beach to the north, Ocean Beach to the south, Mission Beach to the west, and Interstate 5 (I-5) to the east. Within the Improvement Zone are various identified sites for

planned location-specific elements to be analyzed under the program EIR. An overview map of these elements is provided in Figure 2.

PROJECT DESCRIPTION: The proposed project is a program that is specifically intended to address issues related to water quality and water circulation improvements, habitat improvements, and visitor-serving improvements, in specifically identified areas. The program includes the implementation of the following elements: wetland and water quality improvements, shoreline restoration, expansion of habitat preserves, bicycle and pedestrian improvements, restoration of seawall bulkhead, and deferred maintenance activities. Wetland and water quality improvements are focused within several specific areas, including 1) North Fiesta Island, 2) Tecolote Creek and Fiesta Island Causeway, and 3) Cudahy Creek. Shoreline restoration would occur at several locations including 1) Vacation Island NW, 2) Vacation Island NE, 3) Vacation Island SW, 4) Ventura Cove, 5) Crown Point, 6) West Sail Bay, 7) Bonita Cove, and 8) Bahia Point. Expansion of habitat preserves and upland habitats would occur at Fiesta Island and the San Diego River floodway levee. Bicycle and pedestrian improvements would occur baywide with four main locations identified as key areas; 1) Rose Creek Bike Path, 2) Fiesta Island Causeway, 3) Ocean Beach Bike Path, 4) Robb Field Gateway Connectivity; and include several elements, including missing portions or gaps in bicycle and pedestrian paths, signage*, sustainable lighting*, and parking lot repairs*. The restoration of the seawall bulkhead would occur along the oceanfront at Pacific Beach and Mission Beach. Deferred maintenance would occur bay-wide and include maintenance of the following facilities: playgrounds, comfort stations, furnishings, and parking lot repairs (including stormwater best management practices, called BMPs). A Preliminary Engineering Report (PER) will be prepared up to 30% complete design for each of these location-specific elements.

The EIR will analyze the 30% design PERs at a project level, while bay-wide elements will be analyzed at a program level. The proposed program may also include amendments to the Mission Bay Park Master Plan and Local Coastal Program.

PROJECT ACCESS: Regional access to the program site is provided by Interstate (I)-5 from the north and south, and I-8 from the east. Access to each individual element of the program is provided by local roadways surrounding Mission Bay Park.

PROJECT INFRASTRUCTURE: Infrastructure associated with the program includes stormwater drains, culverts and outfalls, and transportation infrastructure such as bikeways, sidewalks, comfort stations, signage, and parking lots.

OFF-SITE IMPROVEMENTS: Offsite improvements are not part of the proposed program.

CONSTRUCTION AND PHASING: The program includes up to 30% design of several elements, which would be analyzed in the EIR at a project level. A conceptual construction duration for each of these elements is analyzed as part of the EIR. The timing for programmatic elements such as shoreline stabilization and bike and pedestrian improvements is not defined although consideration for sequencing elements within the program will be evaluated.

RECOMMENDED FINDING: Pursuant to Section 15060(d) of the CEQA Guidelines, it appears that the proposed program may result in significant environmental impacts in the following areas: Air Quality; Biological Resources; Energy, Geology and Soils, Greenhouse Gas Emissions, Historic Resources (Built Environment and Archaeological Resources), Health and Safety, Hydrology and Water Quality, Land Use, Noise, Recreation, Tribal Cultural Resources, and Cumulative.


