ITEM-2 CONDITIONAL USE PERMIT NO. 89-1173 AND RESOURCE PROTECTION ORDINANCE PERMIT NO. 89-1173 FOR KFMB RADIO. LOCATED ON THE NORTHWEST CORNER OF MISSION GORGE ROAD AND MAST BOULEVARD IN THE R1-40000 ZONE WITHIN THE EAST ELLIOT COMMUNITY PLAN AREA; EQD NO. 89-1173. OWNER/APPLICANT: MIDWEST TELEVISION, INC.

PROPOSED EXTENSION OF SAN YSIDRO INTERIM ORDINANCE
NO. 17286. THIS ORDINANCE WOULD CONTINUE FOR ONE YEAR,
THE PLACEMENT OF RESTRICTIONS ON THE ISSUANCE OF BUILDING
PERMITS, DEMOLITION AND REMOVAL OF STRUCTURES AND
CONSTRUCTION OF MULTI-FAMILY RESIDENTIAL DEVELOPMENT IN
SAN YSIDRO AND THE URBANIZED PORTIONS OF THE TIJUANA
RIVER VALLEY. THE PURPOSE AND INTENT OF THE ORDINANCE IS
TO ENSURE THE PROVISION OF NEEDED PUBLIC FACILITIES AND
NEIGHBORHOOD COMPATIBILITY. THE EXISTING ORDINANCE WILL
EXPIRE ON MAY 31, 1990. THIS WOULD BE SEVERAL MONTHS
BEFORE THE ESTIMATED DATE OF ENACTMENT OF PERMANENT
REGULATIONS TO IMPLEMENT THE UPDATED SAN YSIDRO COMMUNITY
PLAN.

ITEM-4 MID-CITY CLASSIFICATION OF PROTECTED SINGLE-FAMILY NEIGHBORHOODS FOR AREA 6 (AND 20) IN THE MID-CITY COMMUNITY. ON NOVEMBER 16, 1989 THE PLANNING COMMISSION APPROVED THE SINGLE-FAMILY RECLASSIFICATION OF SEVERAL AREAS IN THE MID-CITY COMMUNITY INCLUDING AREA 6 (AND 20). THIS REPORT CLARIFIES THE BOUNDARIES OF AREA 6 (AND 20). OWNER/APPLICANT: CITY OF SAN DIEGO.

JULIE HUDDLE presented Planning Department Report No. 90-009.

RICHARD LINDNER spoke in support of the Single-family Overlay Zone.

WILLIAM CRENSHAW spoke in support of the overlay zone.

JAMES CREAMER spoke in support of the overlay zone stating there had been a change in the area within the last five years with an increase of traffic and parking problems, and crime in the area which he felt was attributable to high-density development.

MARY CORMIER spoke in support of the Single-family Overlay Zone for her neighborhood. She indicated she had a petition containing 159 residents in the area who were in support.

BERNIECE AMBLER spoke in support of the overlay and stated traffic was very heavy in the area.

MARGARET LAUDAN spoke in support of the Planning Department's recommendation that her neighborhood be rezoned to single-family.

BILL THORNTON spoke in opposition to the Single-family Overlay Zone to property he owned in the area.

STEPHEN SCOTT stated he was opposed to the Single-family Overlay Zone being applied to the two and one-half block area on Carol, Bradford and Estelle Streets.

BEN SARKINSIAN spoke in opposition to the Single-family Overlay Zone being applied to property on Bradford Street which he felt was multi-family.

Public testimony was closed on this item.

COMMISSION ACTION

On motion of SCOTT BERNET, seconded by RALPH PESQUEIRA, the Commission voted 7-0 to follow staff recommendation and apply the Single-family Overlay Zone to that area west of Estelle Place shown on Attachment 5.

On motion of SCOTT BERNET, seconded by RALPH PESQUEIRA, the Commission voted 5-2 (ZOBELL and BENN voting in the negative) to recommend the MR-3000 Zone for that area on Bradford and Carol Streets shown on Attachment 5.

On motion of SCOTT BERNET, seconded by EDWARD REYNOLDS, the Commission voted 7-0 to follow staff recommendation with respect to the recommended R1-5000 Zoning on Adalaide Avenue as shown on Attachment 5.

JIM RAGSDALE reviewed the Project Evaluation Report for the format for Community and General Plan Development.

PHIL WALLING, representing the Chamber of Commerce, indicated that they had some disagreement with the Parking Management Plan contained in the Centre City Plan.
