ITEM-9: FAIRBANKS COUNTRY VILLAS – PROJECT NO. 3327. VESTING TENTATIVE MAP, PLANNED RESIDENTIAL DEVELOPMENT, RESOURCE PROTECTION ORDINANCE AND EASEMENT ABANDONMENT.

#### **COMMISSION ACTION:**

The applicant was encouraged to keep the affordable housing on site to allow a diversity of housing opportunities for people within the neighborhood. #### **COMMISSION ACTION:**

MOTION BY LETTIERI TO RECOMMEND TO THE CITY COUNCIL THAT THEY APPROVE STAFF'S RECOMMENDATIONS AND CERTIFY MITIGATED NEGATIVE DECLARATION NO. 99-1331, ADOPT THE MMRP AND APPROVE REZONE, VESTING TENTATIVE MAP, RESOURCE PROTECTION ORDINANCE, PLANNED RESIDENTIAL DEVELOPMENT, EASEMENT VACATION AND MHPA BOUNDARY ADJUSTMENT. Staff was directed to delete finding No. 2 in Attachment 19 regarding gated communities as it does not apply to this project, and modify the drawing in Exhibit A to clarify that the gates will allow pedestrian access at all times. Second by Schultz. Passed by a 5-0 vote with Commissioners Brown and Steele not present.

# ITEM-11: SAN DIEGO POLICE PISTOL RANGE REORGANIZATION. INITIATION OF AN AMENDMENT TO THE MID-CITY COMMUNITY PLAN AND THE PROGRESS GUIDE AND GENERAL PLAN TO REDESIGNATE 4.36 ACRES FROM PARK AND OPEN SPACE USES TO INDUSTRIAL USE.

MOTION BY LETTIERI TO CONTINUE TO SEPTEMBER 19, 2002 WITH DIRECTION THAT OTHER ALTERNATIVE SITES BE LOOKED AT IN OR OUTSIDE THE COMMUNITY; THAT THE RELATIONSHIP WITH RESIDENTIAL USES BE LOOKED AT; STAFF TO COME BACK WITH AN ANALYSIS OF THE PARK DEFICIT BUT ALSO AN APPROACH TO IDENTIFYING WHAT THE PARK STANDARDS WOULD BE FOR THIS AREA AND WHERE THE PARKS COULD POTENTIALLY GO IF THIS WERE NOT A PARK; LAND OWNERSHIP AND THE NUMBER OF ACRES INVOLVED. Second by Chase. Passed by a 5-0 vote with Commissioners Brown and Steele not present.
