# ITEM-7 LAND GUIDANCE PROGRAM UPDATE

NANCY SCHWARZ presented Planning Department Report No. 92-022.

The Planning Commission discussed the draft "Transit-Oriented Development (TOD) Design Guidelines" prepared by Calthorpe Associated. In general, the Commission supported the basic concept of the program but had questions pertaining to: implementation in urbanized and redevelopment area; incentives to developers; public facility constraints; public acceptance to TOD configurations and land uses; marketability of TOD commercial uses; implication for open space preservation efforts; affordable housing opportunities; and the overall implementation program. The Commission asked that the item be brought before them for one or possibly two noticed public hearings.
