ITEM-2 APPROVAL OF MINUTES

#### COMMISSION ACTION

On motion of TOM LA VAUT, seconded by SCOTT BERNET, the Commission voted 5-0 (BENN and CALKINS not present) to approve the minutes of January 24, February 7 and February 14, 1991.

CLEAN WATER PROGRAM - AMENDMENTS TO THE PENINSULA,
MIDWAY, SAN YSIDRO, OTAY MESA-NESTOR, AND OTAY MESA
COMMUNITY PLANS; THE TIJUANA RIVER VALLEY PLAN AND THE
PROGRESS GUIDE AND GENERAL PLAN AND THE CITY'S LOCAL
COASTAL PROGRAM.

ANNA McPHERSON presented Planning Department Report No. 91-087.

DAVE SCHLEISINGER reviewed the program.

NORMAN MAGNESON, President of Peninsula Community Planning Group, stated they were opposed to any expansion of the Point Loma facility to accommodate secondary treatment. He felt the environmental document did not adequately establish the need for secondary treatment related to ocean outfall. He preferred expansion of the Point Loma facility over establishment of a facility at the Midway site.

JOE ONG, Environmental Protection Agency, stated that the environmental document did comply with the requirements of CEQA and NEPA.

Public testimony was closed.

#### COMMISSION ACTION

On motion of SCOTT BERNET, seconded by RALPH PESQUEIRA, the Commission voted 5-0 (BENN and CALKINS not present) to certify the environmental impact report, recommend approval of staff's recommendation with respect to community plan and local coastal program amendments, modified to recommend the Point Loma Site as the

preferred site for secondary treatment over the proposed Midway site. Further, approval of these amendments were with the understanding that such amendments are required under compulsion of the draft Consent Decree regarding the City of San Diego's intent to comply with the Clean Water Act.

ITEM-4 DETERMINATION OF VACANCY RATE FOR APARTMENT RENTAL UNITS.

LEE BATES, Housing Commission, gave a slide presentation of the projects reviewed during the Commission's recent field trip.

FAN SHIU indicated his support for the Housing Density Bonus program.

JACK WALSH spoke in support of the density bonus program.

DENISE CARTER spoke in support of the program.

BOB CARPENTER, representing the San Diego Interfaith Housing Foundation, spoke in support of the density bonus program.

FRANK JORDAN, representing the NAACP, spoke in support of the program.

REV. MARSHALL SHARPE stated he was in support of the density bonus program.

LEON HOGG stated he was in support of the program.

ANNA MAJOR, representing the Southeast Development Committee, recommended that their community be exempt from the program for at least ten years.

VERNA QUINN spoke in opposition to the program in her community.

OPAL TRUEBLOOD spoke in opposition of the housing density bonus ordinance as currently drafted.

Public testimony was closed.
