- Councilmember visited the Tijuana River Valley and met with EPA and CDC. San Diego regional water board invited Maria Elena to talk about the improvements made with the wastewater treatment plan. After tropical storm, Hillary only one of six influent pumps were active, now three of six are operational. Primary sanitation tanks zero out of five were operational, now one is operational.
