# A. **COUNCILMEMBER MORENO'S OFFICE:** (Victor Caymaris)

- City of San Diego Bicycle Master Plan Update
  - The City began an update to our **Bicycle Master Plan** in August and asked the public to provide input on their 'lived riding experience' via online surveys. (until September 30, 2024)
  - We encourage people to visit the project engagement website to learn about the plan update; you'll find information about the project background, its timeline, a fact sheet, and interactive tools so you can provide your input.

     (note: differs from SANDAG's current and ongoing bike projects)
- Tijuana River Valley
  - On the Mexican side, the San Antonio de los Buenos plant construction will be done in the next few weeks and operational by December 2024/January 2025 + the adjacent "Colector Costero" project, 4+ years in the making but stopped due to the Covid-19 pandemic, will be coming online in next month.
  - On the U.S. side: Councilmember Vivian Moreno is working on a resolution to call on federal authorities to declare a State of
     Emergency regarding the TRV situation, engaging the mechanism for additional funds to be allocated for this pressing issue
     and allowing the State of California to follow suit.
- CIPs in Otay Mesa (Siempre Viva Road Improvements & Airway Road Improvements).
  - Both projects are in the Planning phase and already listed on the CIP map tool for upcoming feasibility studies
  - P19006 (Siempre Viva Rd) "[...] feasibility study of modifying the existing road to a six-lane primary arterial road from La Media Road to Otay Center Drive."
  - P19007 (Airway Rd) "feasibility study to upgrade Airway Road into a four-lane major roadway, extending from La Media Road to Harvest Road. The feasibility study shall include, but not be limited to, a preliminary cost estimate, conceptual design, preliminary environmental assessment, and related traffic analysis."
- Capacity Building Grant (CBG) applications.
  - Renewed funding opportunity for FY25 from the Economic Development Department.

- The goal of the CBG program, funded through the Small Business Enhancement Program, is to encourage inclusive economic growth in our region by supporting community-based organizations that directly assist small businesses in under-resourced communities within the City of San Diego.
- Capacity Building Grant proposals can be between \$10,000 \$30,000 and may include but are not limited to providing technical assistance to businesses, building a website, hanging banners, programming special events, or creating/updating business directories. Only non-personnel expenses qualify. This program is dedicated to nonprofit organizations serving small businesses within the San Diego Promise Zone, Opportunity Zones, and under-resourced communities. Applications close on September 27.
- FY25 Community Projects, Programs, and Services (CCPS) update.
  - Council offices review ongoing (from 9/2/24 to 9/20/24) followed by City Attorney Review (from 9/30/24 to 10/18/24) > Award announcements scheduled for the end of October (tentative)
  - "379 eligible projects [applied] from 296 unique community organizations, representing just over \$7.3 million in total funding requests. [...]" (for perspective: each District receives \$100,000 to allocate).
