NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Little Italy Tree Lighting & Christmas Village

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: India St. between West Cedar and West Grape Streets, West Date between Kettner Blvd and India St, and West Fir between Kettner Blvd and Columbia Streets in Little Italy

PROJECT DESCRIPTION: Special Event Permit for the Little Italy Tree Lighting & Christmas Village that would occur on December 7, 2024, on India Street between West Cedar and West Grape Streets, West Date between Kettner Blvd and India St, and West Fir between Kettner Blvd and Columbia Streets in Little Italy (see attached maps). The event would include a tree lighting event, vendors, a stage, sound amplification, generators, entertainment, canopies, tables, chairs, fencing and/or barriers, portable restrooms, trash/recycling containers, food trucks, and onsite food preparation. Noise associated with the event activities and set-up/dismantling would occur on December 7, 2024, from 10 AM until 11:55PM. Set-up would occur from 10 AM until 3:45 PM, the event would occur from 4 PM until 8 PM, and dismantling would occur from 8 PM until 11:55 PM.

Road and parking closures would be associated with the event and would occur on December 7, 2024, from 10 AM to 11:55 PM and would include India Street between West Cedar and West Grape Streets, West Fir Street between India Street and Kettner Boulevard, and West Date Street between India St and Kettner Boulevard. Relocation of handicap parking would be moved from India & W. Date Streets to Columbia & W. Date Streets

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Appeals filed In-Person: The Environmental Determination Appeal Application Form [DS-3031](#) can be obtained at: <https://www.sandiego.gov/sites/default/files/legacy/developmentservices/pdf/industry/forms/ds3031.pdf>. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

The appeal application can also be obtained from the City Clerk, 202 'C' Street, 1st Floor Lobby, San Diego, CA 92101. This information will be made available in alternative formats upon request.

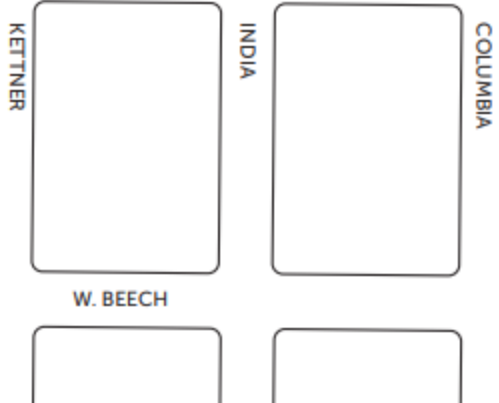

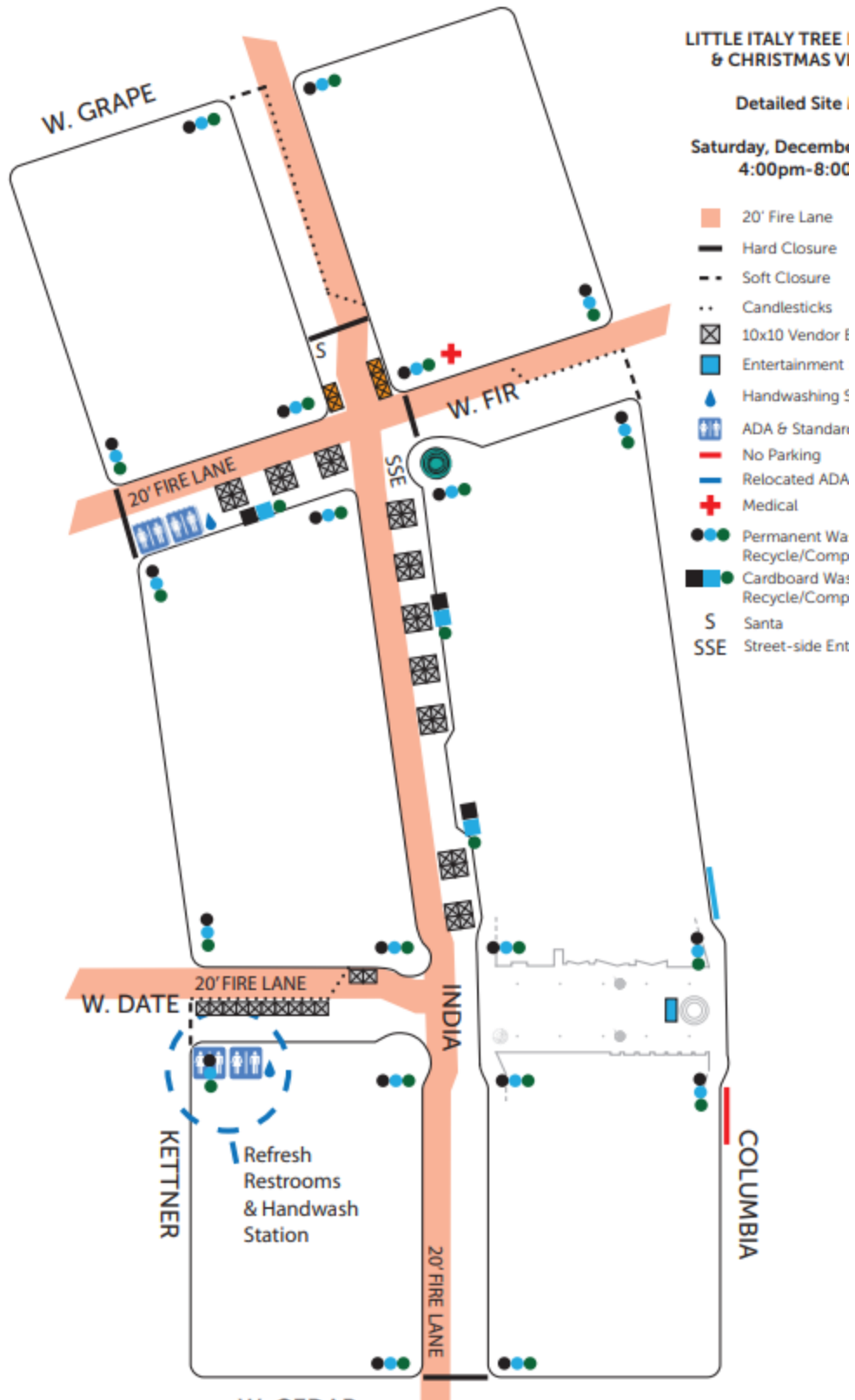
