NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - SoNo Fest & Chili Cook-Off
COMMUNITY PLAN AREA: North Park
COUNCIL DISTRICT: 3
LOCATION: Thorn St. between 31st and Bancroft St., and 32nd St. between Upas and Thorn St.

PROJECT DESCRIPTION: Special Event Permit for a chili cook-off event that would include a cooking competition, vendors, food trucks, onsite food preparation, a fenced-in beer garden, kids' zone, tables, chairs, canopies, a stage, sound amplification, entertainment, portable restrooms, trash/recycling containers. and barriers on December 8, 2024, on Thorn Street between 31st and Bancroft Street, and 32nd Street between Upas and Thorn Streets (see attached map). Noise associated with the event activities and set-up/dismantling would occur from 4:30 AM until 8 PM on December 8, 2024. Set-up would occur from 4:30 AM until 10 AM, the event would occur from 11 AM until 5 PM, and dismantling would occur from 5 PM until 8 PM.

Road closures associated with the event would occur from 4:30 AM until 8 PM on December 8, 2024, and would include Thorn Street between 31st Street and Bancroft Street, and 32nd Street between Upas and Thorn Streets and additional street parking closure east and west sides of Herman Street, starting at Thorn Street and ending 65 feet north of Thorn Street.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
