NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Girls on the Run San Diego 5K

COMMUNITY PLAN AREA: Mission Bay Park

COUNCIL DISTRICT: 2

LOCATION: De Anza Cove Park and surrounding pathways; 3000 N Mission Bay Dr, 92109

PROJECT DESCRIPTION: Special Event Permit for the Girls on the Run 5K event that would include the route, a stage, entertainment, vendors, and the temporary use of canopies, a generator, fencing and/or barriers, tables, chairs, pre-packaged food, non-alcoholic beverages, portable restrooms, and trash/recycling containers to occur in De Anza Cove Park area within Mission Bay Park on December 15, 2024. Noise associated with the event activities and set-up/dismantling would occur from 12 PM on December 14, 2024, until 12 PM on December 16, 2024. A stage would be used for announcements/entertainment, and sound amplification would occur from 8 AM until 10:30 AM. On December 14, 2024, set-up would occur from 12 PM until 5 PM. On December 15, 2024, the event would occur from 5 AM until 12 PM, and dismantling would occur from 7 AM until 12 PM on December 16, 2024. Approximately 2,000 attendees are anticipated throughout the course of the event. See route map and turn by turn directions attached.

Road and parking closures would be associated with the event and would include:

De Anza Road between Mission Bay Drive and the dead end/turnaround from 9 AM until 10:30 AM, and Mission Bay Drive across Clairemont to E. Mission Bay Drive from 9 AM until 10:30 AM on December 15, 2024. The De Anza Cove parking lot, and the parking lot off N. Mission Bay would be unavailable for public use from 6 AM until 12 PM on December 15, 2024. See map attached.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**December 10, 2024**). Appeals to the City Clerk must be filed via email or in-person as follows:

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Appeals filed In-Person: The Environmental Determination Appeal Application Form [DS-3031](#) can be obtained at: <https://www.sandiego.gov/sites/default/files/legacy/developmentservices/pdf/industry/forms/ds3031.pdf>. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
