Committee Comment:

Michael Robinson – Important to have user involvement in design. All voices should be heard. Interested in participating in the exercise.

Chris Eddy – Need to expand the dialogue with local community groups, the more voices the better. Need to figure out how to reach out to communities throughout San Diego.

Makeda Cheaton – Agreed with previous comments, communities need to be involved with Balboa Park Master Plan.

Tim Shields – In favor of including various communities in the Balboa Park Master Plan. Should also include cultural groups input.

Howard Blackson – Feels it is the right time to create a framework for the Balboa Park Committee to engage the community.

Allison Soares – In favor of the efficiency of the model. Wants to see the best ideas brought to the committee.

Howard Blackson (responded) – Wants to see the Balboa Park Committee to create a structure to hear community input on Master Plan.

Jon Richards – Goal is to hear all of the best ideas and create the best path forward. Need to consider how everyone utilizes Balboa Park.

Howard Blackson (responded) – Need to find receive feedback from all users to find the values and create the right changes and updates.

Jon Richards (responded) - Need to identify who are we missing when we are seeking feedback.

Howard Blackson (responded) – Thinks the Balboa Park Committee is the right forum to hear the different voices.

Item 6. AEA Prioritization Framework update: Laura Zucker and Catalina Casas

Public Comment:

Daniele Laman – Commented on the age of the plumbing in Balboa Park. Commented on the need for electrical upgrades for the International Cottages.

Howard Blackson – Acknowledged the low score for innovation. Questioned the difference in scoring for accessibility.

Catalina Casas (responded) – Accessibility in the scoring is based on communities that are historically underserved.

Howard Blackson – Questioned how to make the scoring objective.

Laura Zucker (responded) – Stated difficulty in creating objective scoring. Stated health and safety concerns are prioritized.

Allison Soares – Asked about the most surprising part about the scoring.

Laura Zucker (responded) – Stated the number and types of projects were overwhelming. Scoring should be viewed as a guideline.

Tim Shields – Asked to create an operating guideline document for reference.

Laura Zucker (responded) – Stated AEA can provide an operator guide.

Allision Soares - Asked how public can learn of the project list.

Laura Zucker (responded) – Suggested sharing draft publicly.

Catalina Casas – AEA is recommending studies on health and safety for priority projects.
