David Cortez, Director of Engineering and Construction, San Diego Association of Governments
David Cortez from SANDAG presented on the Imperial Avenue Bikeway project.

- Project planning began in 2015, preliminary clearance in 2018, final design in 2019, and current construction phase in 2024. Anticipated to be complete by 2026.
- 3.5 mile bikeway along Imperial Avenue from 17th to 47th Street.
