Application has been filed with the City of San Diego for a Process 4 (Discretionary) Conditional Use Permit proposing a 12-bed residential care facility at an existing one-story single dwelling unit located at 6052 Wunderlin Avenue. The 0.22-acre site is in the RS-1-6 Zone, Airport Land Use Compatibility Overlay Zone (San Diego International Airport), Airport Influence Area (San Diego International Airport – Review Area 2), Very High Fire Hazard Severity Zone, and Transit Priority Area within the Encanto Neighborhoods Community Plan Area.
