# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME / NUMBER:** Cannabis Outlet/Facility-CO and CPF 4909 Pacific Highway / PRJ-1107595

**COMMUNITY PLAN AREA:** Linda Vista

**PROJECT DESCRIPTION:** CONDITIONAL USE PERMIT (CUP) and COASTAL DEVELOPMENT PERMIT (CDP) amendments for expansion of Cannabis Outlet (PMT-3182554) and reduction of Cannabis Production Facility (PMT-3203668). CO (Suite A) will expand to 3,000 square-feet (SF). CPF (Suite B) would be reduced to 29,829 sf. No expansion or reduction to the exterior envelope of the existing 32,829 sf commercial building is proposed. The site is located at 4909 Pacific Highway in the IL-3-1 Zone, the FAA Part 77 Notification Area, the Coastal Zone (Non-App Area 2), Prime Industrial Lands, Airport Influence Area for SDIA and NAS North Island, Parking Standards Transit Priority Area, Transit Priority Area, and Campus Parking Impact in Council District 7

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego Development Services Department

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301, Existing Facilities.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential to cause a significant effect on the environment. The project meets the criteria set forth in CEQA Section 15301, which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The project is requesting an Amendment to the previously approved CUP and SDP and would not result in an expansion or reduction to the exterior envelope of the existing commercial building. Therefore, this

exemption was deemed appropriate. In addition, the exceptions listed in CEQA Section 15300.2 would not apply. **The site is not included on any list compiled pursuant to Government Code Section 65962.5 for hazardous waste sites.**
