#### **ITEM 1: 9860 LA JOLLA FARMS BOULEVARD – PROJECT NO. 1055647**

**City Council District:** 1

**Plan Area:** La Jolla

Coastal Development Permit and Site Development Permit to demolish an existing pool, including pool deck and jacuzzi, and construct a new, 712 square foot (SF) Accessory Dwelling Unit (ADU) under the existing pool deck, with a new pool and jacuzzi to be constructed on the southwest portion of the site. In addition, minor renovations to the existing single dwelling-unit will include a new wine cellar and hallway. The 0.80-acre project site is in the Residential Single-Unit (RS1-2) Zone, Coastal Height Limit Overlay Zone, Coastal Overlay (Appealable) Zone, Coastal Overlay Zone First Public Roadway, Parking Impact Overlay Zone, Parking Standards Transit Priority Area, and Environmentally Sensitive Lands (Sensitive Biological Resources and Steep Hillsides), and is located at 9860 La Jolla Farms Road, also known as Assessor's Parcel Number 342-031-21-00. This development is within the Coastal Overlay Zone.

The project completed a California Environmental Quality Act (CEQA) Section 15162, Subsequent Environmental Impact Reports (EIRs) and Negative Declarations consistency evaluation analysis based on the Pike Residence Negative Declaration (ND) (Project No. 92-0733). [Report No. HO-24-055](#).

#### **ITEM 2: 2352 CALLE DEL ORO – PROJECT NO. 1079574**

**City Council District:** 1

**Plan Area:** La Jolla

Coastal Development Permit and Site Development Permit for the demolition of an existing 2,427-square-foot single dwelling unit and detached 616-square-foot garage and construct a two-story 7,811-square-foot single dwelling unit with an attached three-car garage, pool, spa, a detached 596-square-foot accessory

dwelling unit (ADU), and associated site improvements. The project is at 2352 Calle Del Oro in the La Jolla Shores Planned District – Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area 2), the Coastal Height Limitation Overlay Zone, the Parking Impact Overlay Zone (Beach Impact), and the Complete Communities Mobility Choices (Mobility Zone 4) within the La Jolla Community Plan and Local Coastal Program Land Use. This development is within the Coastal Overlay zone.

This project was determined to be categorically exempt pursuant to Section 15332, In-fill Development Projects, of the California Environmental Quality Act. [Report No. HO-24-056](#).

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.
