ITEM 1: 10601 TIERRASANTA BOULEVARD – PROJECT NO. 1104246

Plan Area: Tierrasanta

Conditional Use Permit for the 24-hour operation of a proposed fitness center within an existing 4,795-square-foot (sf) commercial tenant space within an existing commercial shopping center. The 13.76-acre project site is located at 10601 Tierrasanta Boulevard in the CC-1-3 (Commercial - Community) zone, the Airport Land Use Compatibility Overlay Zone, the Airport Influence Area (MCAS Miramar and Montgomery Field Review Area 2), and the Federal Aviation Administration (FAA) Part 77 Notification Area for MCAS Miramar and Montgomery Field Airport within the Tierrasanta Community Plan area.

This project was determined to be categorically exempt pursuant to Section 15301, Existing Facilities, of the California Environmental Quality Act.

Coastal Development Permit and Site Development Permit for the construction of a new two-story, single dwelling unit with a basement, garage, pool, and associated site improvements on an empty lot addressed as 2538 Ruelle Nicole, in the La Jolla Shores Planned District – Single-Family (LJSPD-SF) zone, Coastal (Non-Appealable) Overlay Zone within the La Jolla Community Plan area. This development is within the Coastal Overlay zone.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303, New Construction or Conversion of Small Structures. [Report No. HO-24-045](#).

ITEM 3: 809 SUNSET COURT – PROJECT NO. 1111718

Plan Area: Mission Beach

Coastal Development Permit to demolish an existing 700 square-foot dwelling unit and construct a new 1,560 three-story single dwelling unit with an attached Accessory Dwelling Unit and garage located at 809 Sunset Court in Mission Beach. The 0.28-acre site is in the MBPD-R-N Base Zone, Coastal (Appealable) Overlay Zone within the Mission Beach Community Plan Area. This development is within the Coastal Overlay zone.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) and 15303 (New Construction) of the California Environmental Quality Act. [Report No. HO-24-057](#).

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the meeting location as identified herein in a binder labeled “Late-Arriving Materials”.
