James Milch, representing Congregation Beth Israel. Discussed this ordinance with the City Attorney, recognizing in its exception clause the enactment of state law that occurred which states, "a church property that does not want to be historically designated" cannot be involuntarily designated a historic site". If they are planning to move somewhere to build in a new location, they would have no money to build a new church. Requested that a reflection on that state of the law should be in this ordinance.
