- B. Approval of **Proposed Letter:** Subject: Urgent Request for Safety Measures at North Park Parking Garage:

I am writing on behalf of the North Park Planning Committee to raise a significant health and safety concern regarding the ongoing issue of bottles being thrown from the upper levels of the North Park Parking Garage. This matter has been formally noted at least twice, and while we are fortunate that no one has been injured so far, the potential danger to pedestrians and vehicles in the area is substantial.

We believe this situation warrants immediate and visible action to prevent a serious incident in the future. Increased security patrols on all levels of the parking facility and/or installing cameras on all levels with live monitoring by security personnel, could be effective deterrents. This would help ensure that those responsible for these dangerous actions are identified and held accountable. Also as a positive side of effect, a community that feels safer in and around the parking facility is more likely to use the facility without concerns of personal or property harm.

We acknowledge that North Park Main Street and the police are working on this issue. We endorse their efforts and request prompt action to mitigate the risks involved. We are open to discussing this further and would appreciate any updates regarding potential measures that can be implemented."
