- B. Liz Saba there are 8-10 kids ages 12-15 stealing beer from Target then throwing bottles down from the parking garage rooftop. Police have not solved this.

III. Elected Official & Planner Reports (6:55-7:15 pm) (2 minutes each)

- A. Randy Reyes, Hon. Todd Gloria, Mayor of San Diego, randyreyes@sandiego.gov
 - 1. Administration has passed \$1B in grant awards that have funded a variety of city projects.
 - 2. H Barracks + safe parking for homelessness, hundreds of new shelter beds serving different populations.
 - 3. City has fixed 1650 mi of streets in less than 4 years and made street repair a top funding priority.
 - 4. Overhauling the city preservation ordinance to require utilities to restore things to as they were before.
 - 5. Smart streetlights, fentanyl action, banned ghost guns, new police and fire chief, 24 park improvement projects approved
- B. Gonzalo Rocha-Vazquez. Toni Atkins, State Senate Dist. 39, (619) 688-6700 Gonzola.Rocha-Vasquez@sen.ca.gov
 - 1. Office will continue operations through the end of November. The next senator will then take over after the election.
- C. Logan Braydis, Hon. Stephen Whitburn, City Council Dist. 3, (619) 236-6633 LBraydis@sandiego.gov
 - A few weeks ago the city expanded safe sleeping sites by over 200 tents. O lot will have 182 additional spaces and 20th and B will have 53 new spaces. Operated by Dreams for Change.
 - 2. Whitburn introduced an ordinance regulating pedicabs. They have inspired complaints of amplified noise and fare overcharging, which would be banned under the ordinance. Operators would also have to sign a code of conduct.
 - a) Question about state-granted rights for e-bike pedicabs. The ordinance will cover all pedicabs.
 - 3. University Ave mobility project end of this Fall this project will be completed. What's remaining: signal lights along University which will be repaired in Oct or Nov.
 - a) Question about Eastbound bus lanes they are not consistently marked along the whole stretch on the East side.
 - 4. Safe streets resolution ever since this was put forward the office has been getting more traffic calming requests.
 - a) Question about vision zero resolution under this resolution safety will have to be the top priority. Both residents and NPPC need to be involved in getting these traffic calming features.
 - 5. Commonwealth and Juniper the office is advocating for an always stop and a crosswalk there. People are petitioning and writing in, but the spot scored 16/20 necessary points.
 - 6. Nov 14th meeting requested by Terrance, a traffic safety advocate, to meet with businesses at 32nd and Thorn st. The meeting will discuss issues with the narrow streets and see what can be done to improve the area. Unclear if this is a

public meeting, but people who have interests in the area could be involved. This is focused on this particular intersection.

- A. Approve the renewal and amendment of the Neighborhood Use Permit, NUP, for Bluefoot Bar and Lounge PRJ 1103517
 - 1. Urban design subcommittee met and approved the renewal of the permit after some discussion.
 - 2. There were some concerns about noise and parking on certain days with residents in the area.

V. Action/Informational Items

- A. Presentation of upcoming sewer rehabilitation projects, Project Manager: Pedro Melo-Rodriguez, PMeloRodrigu@sandiego.gov
 - 1. Project to do trenchless rehab of 1.46 mi of sewer mains based on age and conditions of the existing system. They were built in the 1980s. There will be 3 areas with excavation where things are broken or not aligned right.
 - 2. Along Arizona st there are some alleys that will be a part of this. Portion between Meade and ElCajon between Oregon and Idaho that will be part of this.
 - 3. New pipes should hast 50 years
 - 4. Residents will be asked to reduce high water use activities during the work. People will be notified with door hangers and notices on cars in the area. Notices go out 5 days before. Will try to avoid towing.
 - 5. 7AM-5PM work. Should begin Spring/Summer 2025 and end Winter 2026.
 - 6. The work is taking into account the growth in the area. No costs to homeowners.
 - 7. There will be a website where progress and timeline on the project can be monitored. Pedro will provide the link once it is live.

 - 1. Election coming up in March. 8 committee members will need to decide if they want to run again. Please let Lynn know.
 - 2. McClish will be election chair. If you're running, you can't help with the election.
 - a) Phase 1 of the election is getting viable candidates. Phase 2 is to encourage the community to vote. Bylaws are prescriptive about how the election is run.

- 2. Desirability and possibility of creating a map of NP that shows new development projects and when permits are applied for. Committee will try to pursue that.

- 4. Want a city planner to let us know the current regulations in this area.
- B. Public Facilities & Transportation: Chair Doug Schueler
 - 1. Bus lanes on University as seen above.
 - 2. Sewer project discussion as seen above.
 - 3. Narrowed traffic lanes between 32nd and Redwood. With parking on both sides there is not room for cars to pass safely. Similar on 33rd st. As community grows, we need to consider these issues of safety for all road users. The meeting in Nov will hopefully address these concerns and start towards solutions. Reach out to subcommittee with thoughts/concerns before the next meeting on Nov 12. That meeting will be here at 6:00.
 - 4. New state law to help safety at pedestrian crossings. This will be implemented next year, so it's hard to judge the effects of this now.
