MOTION BY BROWN TO APPROVE THE MINUTES OF SEPTEMBER 11, 2003 WITH A CORRECTION TO THE REVISION MADE AT THE SEPTEMBER 11, 2003 HEARING TO ITEM NO. 7, CENTRAL POLICE FACILITY, PAGE 3 ITEM 4: ADD THE WORDS "PISTOL RANGE

BUILDINGS' TO BE SPECIFIC AS THERE ARE OTHER **TEMPORARY** BUILDINGS ON THE SITE. Second by Chase. Passed by a 5-0 vote with

Commissioner Steele recusing and Vice-Chairperson Schultz not present.

ITEM-10: GLENRIDGE TENTATIVE MAP – PROJECT NO. 6617.

COMMISSION ACTION:

MOTION BY CHASE TO APPROVE THE PROJECT WITHOUT THE WAIVER FOR THE UNDERGROUNDING AND LET THE APPLICANT AND THE CITY NEGOTIATE HOW TO MAXIMIZE THE AMOUNT OF UNDERGROUNDING THAT IS DONE WITHOUT INCREASING THE NUMBER OF POLES. No second.

MOTION BY STEELE TO APPROVE STAFF'S RECOMMENDATION AND APPROVE THE TM NO. 10838 AND WAIVE THE REQUIREMENT TO UNDERGROUND EXISTING OVERHEAD UTILITY LINES. Second by Brown. Passed by a 5-1 vote with Commissioner Chase voting nay and Vice-Chairperson Schultz not present.

MOTION BY CHASE TO RECOMMEND TO THE CITY COUNCIL THAT THEY RE-EVALUATE COUNCIL POLICY 600-25 WITH THE FOLLOWING SPECIFICS:

CLARIFY THAT THE POLICY'S INTENT IS TO REQUIRE PROJECTS TO UNDERGROUND.

LOOK SPECIFICALLY AT THE CRITERIA FOR WAIVERS AS THEY ARE DIFFICULT TO IMPLEMENT IN IN-FILL CONDITIONS IN INCREMENTAL SITUATIONS; OR TO TIGHTEN THE WAIVER REQUIREMENTS SO THAT THEY CLEARLY DEFINE THOSE HARDSHIP CASES VERSUS THOSE INCREMENTAL CASES.

LOOK AT TIMING AND IN LIEU FEES AND OTHER MECHANISMS SUCH AS ASSESSMENTS DISTRICTS OR REQUIREMENTS FOR PARTICIPATION. - OTHER MEANS OF IMPLEMENTATION BECAUSE THERE WILL BE A TIME PERIOD (LE., OVER THE NEXT 20 YEARS) THAT THIS IS GOING TO BE A VERY ACTIVE POLICY;

Rw. Belause Huis will be enacted over a 10/14 long time period.

CONSIDERATION OF FINANCIAL COST SHOULD BE PROVIDED AS PART OF THE PROJECTALLES MEM. 10/14/03 ff

LOOK AT THE POSSIBILITY OF USING MATCHING FUNDS TO ACCELERATE UNDERGROUNDING IN SMALLER NEIGHBORHOODS WITH THE PRIORITIZATION THROUGH A POLICY THAT IDENTIFIES PROPERTIES SIMILAR TO THE PROJECT BROUGHT FORWARD TODAY.

Second by Garcia. Passed by a 6-0 vote with Vice-Chairperson Schultz not present.

ITEM-11: WORKSHOP - SUBSTANTIAL CONFORMANCE REVIEW.
