ITEM-3: SOUTHEAST SAN DIEGO DEVELOPMENT/CONDITIONAL USE PERMIT AMENDMENT NO. 91-0123 CALIFORNIA MOTHER-INFANT.

Corey Braun presented Planning Department Report P-94-182.

Testimony in favor by:

William Gunner and Barbara Cornist, applicant. Both Mr. Gunner and Ms. Cornist explained the California Mother-Infant Program. Advised that they had met with the Southeast Development group and felt the issues were worked out.

Reynaldo Pisano, Southeast San Diego Development Committee. Advised that the Committee was in favor with additional modifications; referred to his letter, dated October 20, 1994 and a previously distributed letter dated October 10, 1994. Main issues referred to the FAR, Building Height, work furloughs, "exoffenders" and, mothers with children.

Public testimony was closed.

COMMISSION ACTION:

MOTION BY NEILS TO CERTIFY THE NEGATIVE DECLARATION, APPROVE THE SOUTHEAST SAN DIEGO DEVELOPMENT PERMIT/CUP AMENDMENT SUBJECT TO CONDITIONS THAT ARE SET FORTH IN STAFF REPORT (ATTACHMENT 4,5, AND 6), WITH THE FOLLOWING MODIFICATIONS:

- PROJECT DESCRIPTION SHOULD BE REVISED TO CHANGE EX-OFFENDERS TO "WOMEN WHO ARE SERVING TIME"; IT SHOULD COVER BOTH A WORK FURLOUGH PROGRAM AND MOTHER-INFANT PROGRAM, BOTH OPERATED UNDER CONTRACTS WITH THE DEPARTMENT OF CORRECTIONS; (THESE CHANGES SHOULD BE MADE IN PARAGRAPH 1 OF DRAFT CUP AND ALSO IN DESCRIPTION OF PROJECT IN OPENING PARAGRAPH OF THE VARIANCE FINDINGS, IN ATTACHMENT 6. SIMILAR WORDS NEED TO BE MODIFIED IN PARAGRAPH 19 ON PAGE 4 OF 4, ATTACHMENT 5, AND IN SUBPARAGRAPH C, PAGE 2 OF 2 ATTACHMENT 6, AND ANYPLACE ELSE THAT MAKES REFERENCE TO "WORK FURLOUGH" STANDING BY ITSELF TO ADDRESS BOTH PROGRAMS.
- 2) ADD THE WORDS AT THE END OF THE SECOND SENTENCE, PARAGRAPH 3, PAGE 2 OF 4, ATTACHMENT 5, "...AND THEREUPON EXPIRE" TO ENSURE THE CLARIFICATION THAT THE PREVIOUS CUP FOR BOTH PROGRAMS WILL CEASE TO EXIST AFTER 90 DAYS OF OPERATION.

Second by Quinn. Passed by a 6-0 vote with Commissioner White abstaining.
