RICHARD SMITH, representing Save Everyone's Access (SEA). He spoke in opposition to the project, regarding the view to the sea, landscaping, and height of the wall.

JAMES SNODY, representing himself and eight other residents: Boggles, Quinns, Fergusons, LaZinskys, Masonis, Simms, Zadenons, and Nassirs. He spoke in opposition to the project to the view corridors along Camino de la Costa, and Via Del Norte, and presented pictures.
