# PLANNING COMMISSION OF THE CITY OF SAN DIEGO MINUTES OF JULY 1, 1993 AT 9:00 A.M. IN THE COUNCIL CHAMBERS - 12TH FLOOR

#### CHRONOLOGY OF THE MEETING:

The meeting was called to order by Chairperson Bernet at 9:05 a.m. The Planning Commission adjourned at 4:45 p.m.

ITEM-1 ANNOUNCEMENTS/PUBLIC COMMENT - ISSUES WITHIN THE JURISDICTION OF THE COMMISSION NOT PREVIOUSLY HEARD.

Chairperson Scott Bernet announced the Linda Vista Interim Ordinance will be continued to July 8, 1993, for additional information requested by the Planning Commission. Miriam Kirshner, of the Planning Department, can be contacted if the Commissioners would like a briefing on the North City Future Urbanizing Area.

JEFF STROHMINGER discussed the issue of noticing procedures.

DAVE ODELL, representing Save Everyone Access. He stated that SEA is concern about public access to the government process, as well as coastal resources, also speaking for the Torrey Pines Association, which has legal concern on this issue. He addressed the issue of staff reports coming out too late for public input, and to get written comments into the packets for the Planning Commission to the secretary prior to the hearing. Mr. Odell requested that Items G and H be continued to July 15, because the environmental impact reports are not out, need time to review and public to respond.

AL STROHLIN spoke on public noticing for Items G and H be continued to July 15, 1993.

Commissioner Benn stated did not receive the environmental documents on Items G and H.

Ella Paris stated the environmental impact reports will be mailed out on July 2, 1993.

Commissioner Bernet stated since the Planning Commission is the first hearing, the environmental impact report requires 14 days prior to the hearing.

Ella Paris this is only a draft not a final.

Commissioner Benn stated what is the urgency of the regulatory relief?

George Arimes, Assistant Planning Director, stated we were directed by City Council to report back to them by August 10. We had to schedule the Planning Commission hearings on Regulatory Relief as soon as possible.

Commissioner Benn said a message needs to go back to the City Council that their time table is unrealistic.

Commissioner Neils stated this is a very tight time table, if the Commission is going to be pushed, so does everyone else.

**Commissioner Quinn** addressed concerns about the environmental impact report and negative declaration.

Chairperson Bernet addressed the issues: 1) strict noticing requirement, 2) draft versus a final environmental impact report; and 3) not enough time for staff to prepare a comprehensive document for these issues. We are addressing staff, who are doing what they are told to do, would like a response to these issues on July 8.

George Arimes said will discuss these issues with the City Manager on Items G and H, and timeframe for the environmental documents considering the complexity of these items.

Chairperson Bernet requested that someone from the City Attorney office, address the issue if whether or not we have sufficient documents to hear these items, and could get back to us on July 8, 1993.

ITEM-3 REGULATORY RELIEF PROPOSALS

ELLA PARIS presented the memo from the Planning Department dated, June 20, 1993, from George Arimes, Permit Processing Times.

BILL SCHEMPERS, Assistant Director, Engineering and Development Department, gave an overview of all the proposals done by the Engineering Department.

GEORGE ARIMES, Assistant Planning Director, discussed the three major phases of a development project.

ITEM-3C 330 O - LINDA VISTA INTERIM ORDINANCE.

ROBERT KORCH, Senior Planner, distributed drawings and explained each of the conditions that would qualify a project for an exemption.

JENNIFER SULLIVAN spoke in opposition, addressed her concerns that the community needs more time to review and give their input into these proposals, because have alot of potential for impact, and the processes on-going with the zoning code update.

JOANNE PEARSON, opposed, unable to stay.

**CRAIG ADAMS**, Chair of the Uptown Planners, spoke in opposition to the process, not allowing adequate input by the public.

DAVE ODELL, representing himself, spoke in opposition, and stating that this item should have environmental review.

JOHN ZIEBARTH spoke in support of this item.

Public testimony was closed.

## COMMISSION ACTION

On motion of FRISCO WHITE, seconded by CHRISTOPHER NEILS, the Commission voted 3-3 (BENN, QUINN and SKOREPA voting in the negative with MCELLIOTT not present) to approve as modified, Subitem C, development and improvements located entirely on level pad created in accordance with approved subdivision map with the added language would apply D 5 to that definition; requirements for erosion control would be part of the review for development, single-family only, and all of the development would be on level pad. This motion failed not having four affirmative votes.

On motion of FRISCO WHITE, seconded by CHRISTOPHER NEILS, the Commission voted 5-1 (BENN voting in the negative with MCELLIOTT not present) recommend to City Council to approve as amended not to include subitem c,

REYNALDO PISANO, representing Southeast Development Committee, stated on June 14, 1993, the committee voted not to support this item. That moved on buildings would not be an asset.

Public testimony was closed.

On motion of LYNN BENN, seconded by VERNA QUINN, the Commission voted 5-0 (McELLIOTT and NEILS not present) to recommend to City Council not to approve and not to be included for regulatory relief.

ITEM-3D 330 I - LA JOLLA SHORES PLANNED DISTRICT.

ELLA PARIS presented Planning Department Report No. P93-103.

No one spoke in opposition to this item.

On motion of LYNN BENN, seconded by FRISCO WHITE, the Commission voted 5-0 (McELLIOTT and NEILS not present) to recommend to City Council approval of staff recommendation.

ITEM-3E 330 K - BARRIO LOGAN PLANNED DISTRICT.

JEAN CAMERON presented the revised staff recommendation of 20% Deviations in Planned Districts, dated June 25, 1993.

ELLA PARIS presented Planning Department Report No. P93-103.

**REYNALDO PISANO**, representing Southeast Development Planning Committee, spoke in opposition to this item.

Public testimony was closed.

#### **COMMISSION ACTION**

On motion of VERNA QUINN, seconded by ANDREA SKOREPA, the Commission voted 3-2 (BERNET and WHITE voting in the negative with NEILS and McELLIOTT not present) recommend to City Council not to include the language that has been revised under Administrative Review, attachment 2, with the addition to the language after landscaping or architectural and other improvements; and not to amend the Barrio Logan PDO. This motion failed not having 4 affirmative votes. No recommendation by the Planning Commission.
