# ITEM-3 BALBOA PARK EAST MESA PRECISE PLAN.

MIKE TUDURY gave a brief background to the role of the Planning Department in the East Mesa Precise Plan to design and review, and the environmental document. Dave Sorenson, Traffic Engineering, Jeff Koch, Landscaping, and Ellen Mosley, Environmental Planning available to answer questions. Consultants for the East Mesa Precise Plan from the firm of Wallace, Roberts and Todd.

**DEBRA SHARPE** of Park and Recreation Department presented Planning Department Report No. P-92-183.

KATHLEEN GARCIA, Project Director, and LAURA BERNET, Project Landscape Architect, from the Landscape Architectural and Planning Firm of Wallace, Roberts and Todd. Ms. Garcia and Ms. Bernet presented a slide presentation of the 650 acres on the east side, east of Park Blvd.

HUGH KAYE spoke in favor of the plan regarding Florida Canyon and Florida Street is good, does not want another 163 going through the park.

PATRICIA ANDERSON representing a group of homeowners spoke in support of the precise plan and the Perishing Drive realignment. She stated that her and the community would like to be notified of any projects at the beginning not at the end of the process.

PROFESSOR SCOTT ENRLICH, Co-chairman Balboa Park/Morley Field Safe Neighborhood Committee. He spoke in favor of the plan, but had concern of the closure of Florida Canyon and traffic congestion. That Jacaranda Place remain as a open street.

**KEN RALPH** property owner on Florida Street and Golden Hills and spoke in favor of closing Florida Drive and the plan.

JOAN GRIFFIN representing the Eastside Task Force and the Greater North Park Community Planning Committee. She spoke in favor of the plan and has worked with the Park and Recreation Department at the beginning of the process and the committee had input regarding safety, solicit activities and the homeless issue impact.

IONE FAY spoke in opposition to the plan. She addressed the issues of Florida Drive being closed, traffic on Park Boulevard, closing of 26th Street and the soccer field.

LUCY NEALE, homeowner on Alabama Street and north of the park. She spoke in opposition to the plan regarding the notice mailed to her, showed Florida Canyon not existing at all, Upas Street and Morley Field Drive was closed, the map was uncleared. This was made clear to Ms. Neale and now in favor of the plan.

R. T. SHIPLEY lives on Juniper Street, that the fourth fairway goes below his house. He spoke in opposition to the bike path next to the fourth fairway.

GEORGE BURGER lives on Alabama Street one block from the park. He stated not against the Balboa Park East Mesa Plan but opposed to the closing of Florida Canyon Road.

JAY SHUMAKER spoke in opposition to the plan. He addressed the issues: closure of Florida Canyon; bike path by the golf course the 4th fairway; view from the Rose Garden; and traffic congestion.
