Committee Background

Historically, two Area Committees existed, one for each community parks division.

- Sub-committee of the Parks and Recreation Board
- Parks and Recreation Board members were assigned as the Chairperson of each Area Committee.

Current Area Committee Challenges

- Not all communities have a Community Recreation Group (CRG)
- CRG representatives have difficulty attending in-person meetings
- Brown Act requires an in-person quorum, limiting engagement
- Meetings were cancelled often
- Messaging between committees was inconsistent

Therefore, the department has found it challenging to equally disseminate information to all communities across the City.

Restructure Goals

- Boost participation and engagement for all to learn about Department activities
- Provide uniform updates to communities and divisions
- Ensure all patrons feel welcome and engaged in park projects and activities
- Implement equitable and inclusive community engagement
- Reduce barriers that hinder community engagement
- Inform, involve, collaborate and support each community



Restructure Workshops

- Four Joint Area Committee meetings between August and November.
- Monthly workshops held to obtain feedback on the Area Committee restructure.
- Two Area Committee restructure surveys were sent out via email to over 80 participants.
- The survey asked what day and week of the month worked best for everyone and how frequent the committee should meet.
- The majority of the survey results identified restructuring the meetings to the first Wednesday of the month on a bi-monthly schedule beginning in January.
- The survey also gathered respondent feedback on topics, discussions, or information items to include for future meetings.

Recommended Actions

This item seeks approval of the restructure of the Area Committees.

- 1) Change Area Committee structure from two sub-committees of the Parks and Recreation Board to one public forum open to all to attend and participate.
- 2) Remove Article IX, Sub-committees and Committees, Section 2(b) from the Parks and Recreation Board Bylaws to declassify the two Area Committees from sub-committees of the Parks and Recreation Board.
 - Area Community Parks I and II Committees are standing subcommittees of the Board for dissemination of information items to community recreation groups, community advisory bodies, park stakeholder groups, and park users.
 - (i) Area Community Parks I (CP I) is constituted with the geographic location by Council Districts 1, 2, 5, 6, and 7 along with downtown parks and Naval Training Center Park.
 - (ii) (ii) Area Community Parks II (CP II) is constituted with the geographic location by Council Districts 3, 4, 8, and 9 along with Citywide Aquatics, Therapeutic Recreation, Age-Well Services, Mount Hope Cemetery, and Animal Services.
