We are the abutting neighbors at 2526 Ruelle Nicole in La Jolla. We are fine with constructing a house on the adjacent empty lot. However, we are very concerned about the adjacent hillside of this lot with the current proposed plan.

This is a very steep hillside and the construction of a large house and excessive weight on this hillside could cause a landslide or other problems. Creating a landslide is a risk during construction as well as the placement of a large house directly over the edge of the hillside that could very well impact our house and foundation. This not only puts our hillside property at risk, but the structural integrity of our house would also be at risk.

We are asking to please change this plan to a smaller house further back in the property and far enough away from the hillside that will ensure no damage is done to our home or property,
