

## **Business Walks**

### **Purpose:**

- Community organizations and City representatives visit small businesses
- Approximately 100 small businesses along a commercial corridor (1-mile stretch)
- Build relationships and share resources



# **Business Finance Loan Program**

- CARES Act Revolving Loan Fund
- SD Region Revolving Loan Fund


### Eligibility Requirements

- The business has a commercial location in the City of San Diego, with loan funds to be spent at that location
- Businesses must have an active <u>City of San Diego Business Tax Certificate</u>
- The loan must be used to create or retain employment opportunities in the City of San Diego
- Startups interested in applying for a loan must have at least a six-month operating history in a supportive business environment (e.g., incubator, accelerator, business development program, etc.)

# **Storefront Improvement Program (SIP)**


- The goal is to enhance the "curb appeal" of small commercial structures
- Open to businesses located in the City of San Diego with a valid business tax certificate

# **SIP Program Benefits**

- Professional design assistance
- Grant of one-half of expended construction costs







# **SIP Program Benefits**

- Standard Incentive category: single business and will receive half what they spend, up to \$8,000
- Extra incentives for businesses located in an Opportunity Zone, in the SD Promise Zone, or if they are undertaking a historic restoration

Residential structures, Government buildings, and chain stores are excluded



# **Eligible Improvements**

- Awnings
- Lighting
- Signage
- Windows and doors
- Exterior artwork
- Defined outdoor spaces
- Landscaping, planters and street trees
- Building paint and decorative material
- Accessibility modifications
