#### **AGENDA ITEMS**

#### ITEM 1: 7824 GIRARD - PROJECT NO. 1100236

Staff: May Rollin City Council District: 1 Plan Area: La Jolla

Coastal Development Permit and Tentative Map Waiver to allow for the conversion of an existing two-story mixed-use building into three condominium units: a 4,595 square foot commercial unit on the first floor and two residential units on the second floor, totaling 2,753 square feet (Suite A is 1,531 square feet and Suite B is 1,222 square feet). The 0.14-acre site is located at 7824 Girard Avenue (APN No. 350-082-1200) in the La Jolla Planned District Zone 1 (LJPD-1), the Coastal Overlay Zone (Non-Appealable Area), a Parking Standards Transit Priority Area, and the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities), of the California Environmental Quality Act. <u>Report No. HO-24-058</u>.

#### ITEM 2: SPROUTS HORTON OFF-SITE ALCOHOL SALES – PROJECT NO. 1115855

Staff: Carly Gagen-Cheeney City Council District: 3 Plan Area: Downtown

Conditional Use Permit for the sale of alcoholic beverages for off-site consumption at Sprouts Farmers Market, a proposed 26,385-square-foot grocery store located at 200 Horton Plaza, Suite 200 at the "Campus at Horton," a mixeduse development under construction on the full-block site bounded by E Street, G Street, First Avenue and Fourth Avenue within the Employment/Residential Mixed Use land use district of the Centre City Planned District, a Transit Priority Area, and the Horton Plaza/Gaslamp Quarter neighborhood of the Downtown Community Plan. The Project is consistent with the previously certified <u>Downtown Final</u> <u>Environmental Impact Report</u> as amended and no additional environmental document is required under the California Environmental Quality Act. <u>Report No. HO-24-052</u>.

## ITEM 3: 2664 L STREET – PROJECT NO. 1113811

Staff: Karen Bucey City Council District: 8 Plan Area: Southeast San Diego

Tentative Map Waiver to create six residential condominiums, currently under construction. The 0.14-acre project site is located at 2664 L Street within the RM-3-7 (Residential Multiple Dwelling Unit) zone and the Southeastern San Diego Community Plan.

The project is categorically exempt from the California Environmental Quality Act pursuant to Section 15332, In-Fill Development Projects. <u>Report No. HO-24-059</u>.

## ITEM 4: AT&T MOBILITY 54<sup>TH</sup> STREET – PROJECT NO. 1101712

Staff: Karen Howard City Council District: 4 Plan Area: Mid-City/Eastern Area

Conditional Use Permit to continue operation of a Wireless Communication Facility consisting of 12 existing panel antennas and 10 existing remote radio units concealed inside a 78-foot-tall steeple, with a 120-square-foot ground-level equipment area. The site is located at 3060 54th Frontage Street in the RS-1-7 zone and the Eastern Area Neighborhood of the Mid-City Communities Plan.

This project is categorically exempt from the California Environmental Quality Act pursuant to Section 15301 (Existing Facilities). <u>Report No. HO-24-060</u>.
