New Business Items

1. Olivia Mabee and John Ide from City of San Diego presented update on city's tree planting efforts. A 2022 settlement with APCD requires a \$4.6M multi year tree planting project to be completed by 12/31/25. There is also a \$10M grant from the US Forestry Service for 5,000 new trees. City will maintain trees for 3 years and can only be planted on city-owned land. 1,020 trees already planted. The size of the trees are 15 gallon or 6-8 feet tall
2. OG Labor Day event was successful and planning now for next year if anyone wants to join. Meetings start on 1/31/25 at noon at the rec center.
