NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - San Diego Tet Festival

COMMUNITY PLAN AREA: Peninsula

COUNCIL DISTRICT: 2

LOCATION: NTC Park in Liberty Station

PROJECT DESCRIPTION: Special Event Permit for a three-day cultural festival that would occur within NTC Park in Liberty Station on January 31, 2025, February 1-2, 2025. The event would include activities, games, onsite food preparation, alcohol, food and merchandise vendors, live entertainment, generators, a petting zoo, firecrackers, animals, and dancing, fencing and/or barriers, a stage, canopies, portable restrooms, trash/recycling containers, tables, and chairs. Noise associated with the event activities and set-up/dismantling would occur from January 29, 2025. at 9 AM to February 3, 2025, at 5 PM. Set up would occur over five days: January 29, 2025, from 9 AM to 5 PM, January 30, 2025, from 9 AM to 10 PM, January 31, 2025, from 9 AM to 3 PM, and February 1 & 2, 2025, from 9 AM to 11 AM. The event would occur over three days: January 31, 2025, from 4 PM to 10 PM, February 1, 2025, from 11 AM to 10 PM, and February 2, 2025, from 11 AM to 9 PM. Dismantling would occur on February 3, 2025, from 9 PM to 5 PM.

There would be a road closure associated with this event that would include Cushing Road between Dewey Road and Roosevelt Road, and occur on January 31, 2025, from 9 AM to 11 PM, and from February 1, 2025, at 9 AM until February 2, 2025, at 11 PM. Parking closures associated with this event would include Cushing Road between Dewey Road and Roosevelt Road, and occur from January 31, 2025, at 3 PM to February 3, 2025, at 12 PM, and would include parking spaces in the parking lot closest to Dewey Street from January 31, 2025, at 9 AM to February 3, 2025, at 12 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
