Charles Broadbent, Airport Manager, Montgomery-Gibbs Executive Airport, gave a presentation on the services provided by Automated Gate Services. A short discussion took place.

### **B.** Staff Reports

### Chief of Airports - Jorge Rubio, A.A.E.

- Introduced Jason Ponchetti, as the newest member to the Airports Advisory Committee.
- Advised that City Council will entertain adding a new seat to the Airports Advisory Committee for a representative from the Navajo Nation.
- Announced that Hangar Inspections have commenced at Brown Field Municipal Airport.
- Reminded members of the Airports Advisory Committee to sign the City of San Diego Code of Ethics.
- Debriefed about the Unleaded Fuel Bowser Demonstration event that took place at Montgomery-Gibbs Executive Airport in November with Mayor Todd Gloria in attendance.
- Reported that San Diego Airpark lease amendments have been taken to City Council. Phase 1 of the project is expected to be fully built by the end of 2025 calendar year.
- Reported that the Northside of Brown Field lots were about 90% cleared.

### Montgomery - Gibbs Executive Airport (MYF) – Mr. Charles Broadbent, MYF Airport Manager

- MYF had 35,000 Operations in October
- Interviews have been conducted for the vacant Operations Assistant Positions.
- Gate 8 and the pedestrian gate near Marigold have been repaired.
- Airport staff currently working on installing frequency information signs for 28L and 28R.

### Real Estate, Airports Lease Administration – Jennifer Bearse, Program Manager

- Airports have completed evictions at the Aero-Abre leasehold as of August 21, 2024 and has regained possession of all lots.
- A new MOU was drafted for San Diego Fire Station 43 at Brown Field.
- The Experimental Aircraft Association to exercise option to extend the size of the leasehold. A meeting was held in late August with EAA to discuss proposed lease amendment/extension. EAA to conduct environmental review on Option area and decide if they will exercise Option.
- Sorbi Aviation Lease Renewal is in progress. The item is scheduled for ED&IR Committee in December.
- Airports is working with 94th Aero Squadron on short-term lease renewal for patio/outdoor space. Appraisal underway.
- Airports is working on new MOU with Sand Diego Police Department Eastern Substation for 9225 & 9265 AERO Drive. Appraisal underway.
- The new lease and license templates for hangars and tiedowns have been finalized.
- Appraisals are underway for Lot 8A hangars.
- MYF Hangar Inspections scheduled for December 3-5th and 10-12th.
- Airports is obtaining a proposal from Alps Hospitality Group on new lease. Processing a Sublease for a solar project at 8110 Aero Dr. Hotel. Reviewing Glare Study.
- MOU has been executed with Transportation for 3,801 sq. ft. of office space at 8525 Gibbs Drive commencing 10/21/24. Anticipated new annual lease revenue will be \$105,706.
- Parking lot refurbishment work has been postponed until December 3rd and 4th due to contract issues. Contract processed for \$101,000 for refurbishment.
- Phase 2 of roofing repairs to commence shortly. E&CP administering the project.
- E&CP Construction is soliciting bids for replacing the balance of the roof at the retail center.

# 1. Executive Summary

In 2024, the Airports Advisory Committee (AAC) provided input and recommendations on items relating the management of Montgomery – Gibbs Executive and Brown Field airports to City Council and staff. The AAC also took discussion on operational, leasing, redevelopment, and capital improvement program items for both airports. Additionally, the AAC provided input on the Federal Aviation Efforts to transition to Unleaded Aviation Fuels. With the support of the AAC, staff worked on several infrastructure projects, including, the rehabilitation of pavements at both airports to ensure safety and efficiency and operations. Even though the ACC has some vacant positions, the membership was able to meet during most regular scheduled meeting times and held a special meeting to accommodate the ACC's objectives to improve the services and infrastructure at both City airports.

# 2. Mission Statement

The Airports Advisory Committee was established to provide the Mayor and City Council with advice on general aviation issues related to City owned and operated airports. The Airports Advisory Committee: (a) Serves in an advisory capacity to the Mayor and City Council on selected issues related to airport policies and development projects at Montgomery- Gibbs Executive and Brown airports. (b) Provides recommendations to airport staff on selected actions that require Council approval. (c) Conducts public meetings to provide a forum for, and receive input on, airport related issues. (d) Recommends methods of improving communications and relations between the member-represented communities, airport users and the City. (e) Serves as liaisons between the public, airport tenants, and the City. (f) Provides advice, input, and support to the City's Economic Development Department's Airports Division, when requested.

# 3. Overview of the Year

In 2024, the Airports Advisory Committee (AAC) made key recommendations to the City Council aimed at advancing general aviation at City airports for the benefit of the traveling public. The AAC reviewed several airport leasing opportunities that are projected to generate approximately \$1.98 million annually in Airport Enterprise Funds, while also supporting continued industry-related employment. Additionally, the AAC endorsed the transition to unleaded aviation fuels, which led to Montgomery-Gibbs Executive Airport becoming the first public airport in San Diego County to offer UL94 fuel.

Furthermore, the AAC supported staff recommendations to update Fiscal Year 2026 Airports User Fees, helping ensure the financial self-sufficiency of the Airports Enterprise Fund.

As a result of these recommendations, two major events took place: (1) the Groundbreaking Ceremony for the 300-acre San Diego Airpark Redevelopment project at Brown Field Airport



on June 10, 2024, and (2) the launch of retail unleaded aviation fuel at Montgomery-Gibbs Executive Airport on November 1, 2024.

### 3.1 Changes in leadership or structure.

Jason Ponchetti, General Manager of the Air Center San Diego was appointed to the Airports Advisory Committee to replace the vacant position left by Tom Ricotta, as the Brown Field Aviation Lessees Representative position.

# 4. Key Accomplishments

in 2024, the AAC provided recommendations for City Council to approve aeronautical and non-aeronautical leases at City Airports that will generate approximately \$1 million in annual revenues. Also recommended approval to approve the 59 Leases Amendment for San Diego Airpark at Brown Field Airport. And recommended an agreement with the FAA to collect One of those non- approximately \$1 million dollars in back-due rent from the FAA to support the financial self-sufficiency of the Airports Enterprise Fund Additionally, the AAC discussed changes to the vehicular traffic flow at Montgomery Gibbs-Executive Airport, formally introduced new aeronautical entrants, and provided input on operational and maintenance items at the airport.

# 5. Challenges Faced

The number of vacant seats in the Airports Advisory Committee had made it difficult for meetings to reach the required quorum for them to be taken. Due to this complication, the September meeting was cancelled.

# 6. Goals for Next Year

The Airports Advisory Committee (AAC) will continue to advise the City Council and staff on matters that align with the expectations outlined in the Airports Advisory Committee documents, as specified in the City's Municipal Code. More specifically, the ACC looks forward to:

- a) Creating a "Best Practices" document in collaboration with the Montgomery Gibbs Air Traffic Control Tower, local flight schools and flying clubs and out of the area flight schools that routinely fly in and out of Montgomery-Gibbs Executive Airport. This document will clarify procedures that benefit all parties involved. For example, one key guideline is to avoid blocking runway access unless you are first in line for takeoff.
- b) Assist staff in the finalization, adoption, and implementation of the master plans for Montgomery-Gibbs Executive and Brown Field airports.
- c) In accordance with the proposed Montgomery Gibbs Executive Airport, if adopted, begin the lease negotiation for existing small general aviation hangars on City held property, in particular, Marigold and Flattop.



# 7. Conclusion

In 2024, the Airports Advisory Committee played a crucial role in fostering collaboration and innovation within the aviation industry. By tackling critical issues, providing expert guidance, and ensuring adherence to safety and regulatory standards, the AAC contributes to the continuous improvement of both Montgomery-Gibbs Executive and Brown Field airports. As the industry changes, the Airports Advisory Committee's work will be vital in steering aviation toward a brighter and more innovative future for San Diegans to enjoy.




