Background

- In 2024, the newly formed CAB created a Workplan Committee, then decided to split into 3
 Committees organized by priority CAP areas (Strategy 1, 2, 3)
- In December 2024 CAB meeting, a draft Workplan combining items from the 3 Workplan Committees was presented and distributed to all CAB members
- In January 2025, 3 Workplan Committee Chairs and CAB Chair met to develop today's recommendations

Recommendations

- Review & Approve 2025 CAP Workplan
- Dissolve Ad Hoc Workplan Committees
- Create 3 new Ad Hoc committees to focus on initial priorities

Discussion

- The Workplan is a tool to help the CAB organize & prioritize their activities
 - It can be refined over time, some items may shift to next year
 - Note the CAB Chair can agendize additional relevant items as needed
- Each item in the Workplan contains a general timeline of
 - On-going
 - H1 (first half of the year)
 - H2 (second half of the year)
- Work will mostly occur in Ad Hoc Committees
 - · Recommend meeting once a month, zoom acceptable
 - Encourage all CAB members to join at least one committee
 - Committees will provide briefs & recommendations to the CAB
- Work can occur outside of a Committee, coordinated with Chair
