NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION DEVELOPMENT SERVICES DEPARTMENT

PROJECT DESCRIPTION: Conditional Use Permit (CUP) and Coastal Development Permit (CDP) to allow for the continual operation of a Wireless Communication Facility (WCF) located at an existing church site. The WCF consists of six (6) existing facade mounted antennas, six (6) existing remote radio units (RRUs) behind Fiber-Reinforced Panels (FRP). The antennas and RRUs are located on an existing 50-foot-tall church bell tower along with an existing equipment enclosure. No significant changes to the project site are being proposed. The site is located at 1984 Sunset Cliffs Boulevard, in the RM-2-4 Zone, Coastal Overlay N-APP-2, CHLOZ, Ocean Beach Community Plan Area, and Council District 2.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego Hearing Officer

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301 (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego, Development Services Department

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15301 (Existing Facilities). Section 15301 allows for the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing facilities (public or private), involving negligible or no expansion of use beyond that existing at the time of the determination. Since the project would only permit the continual operation of an existing WCF and would not significantly change the project setting, the exemption was deemed appropriate. The project is located on a developed site and no environmental impacts would occur and none of the exceptions described in CEQA Guidelines Section 15300.2 apply.
