## **AGENDA ITEMS**

ITEM 1: 5381 CALUMET AVENUE - PROJECT NO. 1115264

**Staff:** Blake Sonuga **City Council District:** 1 **Plan Area**: La Jolla

Coastal Development Permit to demolish a one-story 1,841-square-foot single-dwelling unit and construct a two-story 3,700-square-foot single-dwelling unit with an attached 497-square-foot garage and a detached two-story 798-square-foot accessory dwelling unit. The 0.17-acre site is located at 5381 Calumet Avenue in the RS-1-7 zone, the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Transit Area Overlay Zone, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15332 (In-Fill Development) of the California Environmental Quality Act. Report No. HO-25-001.

## ITEM 2: AMERICAN TOWER/VERIZON BAYVIEW HEIGHTS - PROJECT NO. 1100637

Staff: Nilia Safi

City Council District: 4

Plan Area: Mid-City/Eastern Area

Conditional Use Permit and Neighborhood Development Permit to continue the operation of an existing Wireless Communication Facility (WCF). The project proposes the continued use of an existing 40-foot-tall faux mono-broadleaf tree that houses 12 antennas and 12 Remote Radio Units (RRUs), and a 548-square-foot equipment enclosure, with no physical changes proposed to the existing facility. The site is an existing church located at 1765 Pentecost Way in the RM-2-6 Zone of the Mid-City Eastern Area Community.

The project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act. Report No. HO-25-002.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.
