# Council Policy 700-42 Update

### Council Policy 700-42 Purpose

The role of Community Recreation Groups (CRGs) is to make recommendations to City Council, the Parks and Recreation Department and its various boards regarding recreation programs in the community, park capital improvement projects and to provide recommendations on the expenditure of recreation center funds.

Council Policy 700-42 provides a process to formally recognize CRGs and establishes requirements that each CRG must follow to be recognized.

Updating the policy provides a framework for CRGs to replace recreation councils previously governed by this Council Policy.



### History of Community Recreation Groups

#### 1950

- Formally known as Recreation Councils
- Groups of volunteers formed to advise and assist the city in the promotion, planning, publicizing, coordinating, and providing of community and recreational programs

#### 1978

- Recreation Councils became a financial partner with the City and started accepting revenues into private bank accounts and gaining control over City funds.
- Recreation Councils began paying expenses for local recreation programs


#### 2005

- Council Policy 700-42 was established
- Recreation Councils required by the city to obtain non-profit status to continue collecting revenue at recreation centers
